

LAYOUT INSTRUCTIONS AND LANTAC CERTIFICATE


LAYOUT AND DIMENSIONS

To be suitable for wheelchair users, W.C. compartments should have at least the equipment, dimensions and layout as shown on the main drawing on page 4. The fixtures and rails included in this pack (plus mirror and light switch) when installed as shown on the drawing provide the facilities required under Approved Document M of the Building Regulations 2004.

Alternative layouts to that shown on the drawing may be acceptable, provided evidence of compliance can be shown. If an alternative layout is used, the attached certificate on page 3 is not valid

HANDING OF LAYOUT

If a building contains more than one wheelchair accessible W.C. facility the opportunity should be taken to hand the layouts. One pack can be used to meet this need. The main drawing on page 4 relates to the left handed assembly but the positioning dimensions are the same for either handing.





FIXINGS

Security of all items is vitally important and it is essential that the fixing instructions with each component within the pack are followed.

Walls onto which rails, sanitaryware and fixtures are mounted must be suitable for load bearing and to take the fixings recommended and supplied.

W.C. - Fixed to floor using pan to floor fixings provided.

CISTERN - Fixed to WC bowl with fixings provided then plugged and screwed to wall using 2 x 50 mm No. 10 woodscrews - (not provided).

WASHBASIN - Securely fixed to a suitable solid wall using bolts and plugs - (not provided).

HINGED RAIL - Secured to wall using suitable heavy duty bolts and plugs - (not provided).

STRAIGHT RAILS - Secured to wall using appropriate screws and plugs - (not provided).

If in doubt over fixing, you should refer to a specialist fixing supplier such as Fischer Fixings: Help line Number 01491 827900.

THERMOSTATIC MIXING VALVE

Uses proven thermostatic technology for temperature control to a maximum temperature preset at 42°C, which can be adjusted if required.

MIXER TAP

A single lever provides blended water at a maximum safe temperature as provided through the thermostatic mixing valve.

6 Ltr FLUSH

The syphon is pre-set to deliver a 6ltr flush.

Using The LABC Registered Solution Certificate (LANTAC)

1. The LABC Registered Solution Certificate opposite is only valid if the fixtures have been positioned in accordance with the details given in this instruction leaflet and shown on page 4.

2. The LABC Registered Solution Certificate should be detached at the perforations and attached to the final approval request documents submitted to the local authority building inspectorate. The building inspector may then check that the layout installed is in accordance with the approved drawing as on the back of the certificate.

3. The LABC Registered Solution Certificate scheme applies throughout England and Wales. In Scotland submission or the certificate may possibly prove evidence of compliance with Document M requirements. 4. The Items contained within this pack along with the mirror and light switch are mandatory.

The contexts of the pack, when fitted in accordance with the manufacturer's instructions will contribute to achieving compliance with Regulation M1 requirements and M3 requirements of the Building Regulations in England and Wales and Mandatory Standards 3.12 and 4.2 of the Scottish Technical Handbooks

The contents of the pack should adhere to the components lists provided in document BOM 4-8-20 and layouts to the drawings provided in the following respective drawing: A25836.

Validity

This system has been checked for compliance in accordance with English, Welsh & Scottish Building Regulations.
