- 2) The tables are allocated on invite basis only. There are limited tables available, so get your payment in ASAP.
- 3) Note that the show runs within Mall hours. You are expected to be set up by 9:30am, stay till the event ends at 5:00pm, and be fully loaded out by 6:00pm. No loading or unloading during mall hours, except with the permission of Curious ComiCon.
- 4) For this show we are bound by Mall Rules. No inappropriate materials or displays, and no smoking, vaping or alcohol on the premises. Displays to be professional, no hand-written signs. All tables must be covered with a tablecloth to be supplied by Curious ComiCon. No part of any display shall exceed five feet (5') in height. No additional tables or stands allowed without permission from Curious ComiCon, you will be asked to remove extras immediately. Please be discrete with food and drink.
