- 1. Any instrument on which the serial number is missing has been removed or altered.
- 2. Any instrument that has not been registered via https://www.diamondguitars.com/register within thirty (30) days of the original purchase date. (Special provisions will be made for instruments purchased prior to X/X/2010)
- 3. Any instrument NOT purchased from an Authorized Diamond Guitars Dealer.
- 4. Any instrument that has been serviced or repaired by that other than an Authorized Diamond Guitars Service Center.
- 5. Any instrument that has been customized or modified in any fashion.
- 6. Any instrument that has been damaged due to an accident, negligence, or misuse.
- 7. Normal "wear and tear", including but not limited to worn frets, string replacement, worn tuners, worn hardware or plating, scratched pickguards, worn saddles & nuts, battery replacement, damage, or discoloration/fading of the instruments original finish.

Remedies beyond normal service or repair require both an evaluation and confirmation from an Authorized Diamond Guitars Dealer or Authorized Diamond Guitars Service Center for alternative considerations. Only an Authorized Diamond Guitars Dealer or Authorized Diamond Guitars Service Center may obtain authorization to return the instrument to Diamond Guitars.
