## Consignment Contract

**A. Terms & Conditions:** Merchandise will be priced & selected at etc. Consignment Shoppe's discretion. Any items found damaged after initial inspection will be sold at a discount or donated without further notice. Upon sale of a consigned item, the Consignor will receive 40% of the final sales price. etc. Consignment Shoppe does not guarantee your items will sell whether expressed or implied. The consignor will pay an initial registration fee of \$5.00. This fee is renewed yearly. By providing an email address consignor agrees to receive emails from etc. Consignment Shoppe.

**B. Consignment Period:** etc. Consignment Shoppe will consign your items for 60 days. It is the consignor's responsibility to know when items expire. At the end of the consignment period (date given when consignment is accepted) you may come to etc. Consignment Shoppe, locate and pick up any unsold items. With 48 hours notice, etc. Consignment Shoppe will be glad to retrieve your items at a cost of \$1.00 per item. A \$10 fee is charged for items picked up before 50 days. Unsold & unclaimed items will become the sole property of etc. Consignment Shoppe. We will not contact Consignor to notify them of account status.

**C. Pricing:** etc. Consignment Shoppe has the sole discretion to determine pricing for maximum profitability. Any items that are price sensitive should be addressed with a etc. Consignment Shoppe associate at intake. Merchandise consigned is subject to any sale held in store or online, as well as a markdown schedule determined by etc. Consignment Shoppe.

**D. Payment:** Profits made from the sale of item(s) consigned may be paid out in cash, check or store credit, at the request of the Consignor. If no activity has been on the account for two years, etc. Consignment Shoppe reserves the right to convert monies owed to store credit. It is the Consignor's responsibility to notify of any change of address. A handling fee will be added to the price tag of each item. That fee is passed to the buyer and will not be reflected on your inventory list and will not be apart of your payment.

**E. Authenticity & Ownership:** It is against the law to sell any counterfeit goods. All items presented for consignment are authentic. Consignor has ownership of property consigned and will not hold etc. Consignment Shoppe responsible for any entitlement to them.

**F. Liability:** We will do our best to protect your consigned items, however all items are left in the store at your own risk, and Consignor will not hold etc. Consignment Shoppe responsible for any damage, including damage caused by theft, fire, vandalism, natural disaster or any other unforeseen circumstances.
