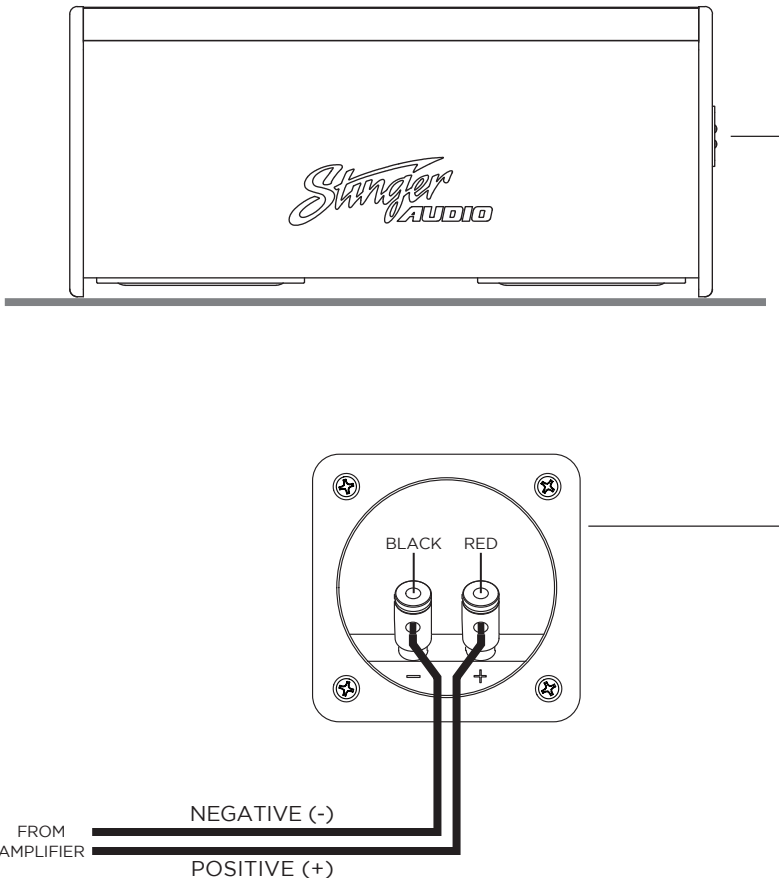
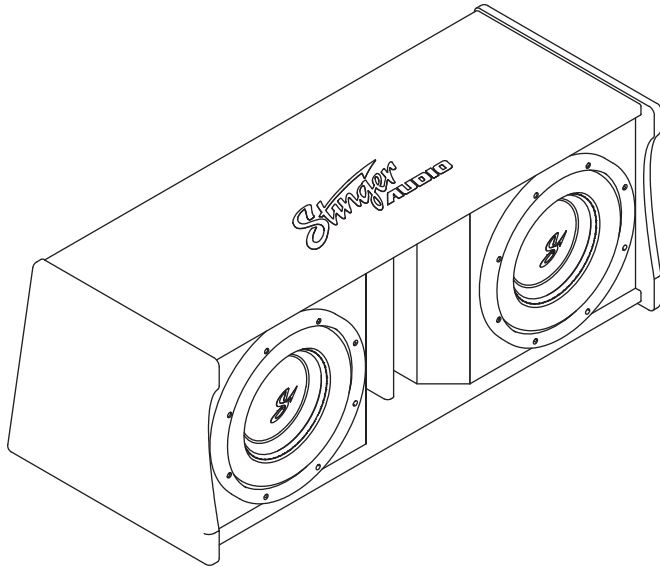

### INSTALLATION TIPS

- ▶ Speaker Wire: 16-12 Gauge
- ▶ Amplifier: 1500-2000 Watts / 1 ohm Stable
- ▶ Subsonic Filter should be set to 30Hz !
- ▶ Ensure the speaker wires are connected correctly: Positive to Positive / Negative to Negative.
- ▶ The enclosure can be placed with the speakers facing forward, backward, upward or downward. Try each position to determine which direction sounds best in the vehicle.
- ▶ Once positioned, the enclosure should be securely anchored.
