

# TRANSPARENT HYDRA SOFT MASK

## SPECIAL FEATURE

With this mask, the skin is immersed in a thirst-quenching care, the active ingredients of which are released throughout the treatment.

## PROPERTIES OF THE INGREDIENTS

Moisturizing  
active ingredient  
of plant origin

Resulting from the association of two humectant molecules capable of retaining water (glucose and xylitol, sugars of plant origin), this active ingredient has complementary actions allowing to increase the water reserves of the skin, to ensure optimal immediate and long term hydration (in vivo test). To make the skin more resistant to external aggressions, it strengthens the skin barrier, thus limiting water loss (in vitro and in vivo tests).

Sodium hyaluronate  
complex

Sodium hyaluronate corresponds to the sodium salt of hyaluronic acid. The latter is one of the most important building blocks of the skin. Its exceptional capacity to retain water makes it a unique hydrating active ingredient.

Sodium hyaluronate of different molecular weights are associated within this formula for complementary actions:

- Two of them, of very low molecular weight (20 to 50 kDa and 100 to 130 kDa), help to rebalance the level of hydration in the skin (in vivo test).
- The third, of high molecular weight (1800 to 2200 kDa), forms on the surface of the skin a non-occlusive moisturizing film (in vivo test) which gives a soft and velvety appearance.

## RITUAL OF BEAUTY

Open the sachet and unfold the mask. Apply the ready-to-use mask to the face on perfectly cleansed skin. Leave on for 15 minutes then remove the mask. Gently massage the excess serum.

Precautions for use: keep away from heat.
