

# ANTI AGE FIBER MASK

## SPECIAL FEATURE

Inspired by the Asian beauty rituals, this sheet mask with its specific cutting form and its ear hooks perfectly fits the face contour. It is soaked with a serum made up of anti-ageing active ingredients, in particular apple stem cells, a ultimate anti-ageing active ingredient. The first signs of ageing are reduced, the skin preserves its beauty, freshness and radiance.

## PROPERTIES OF THE INGREDIENTS

### PhytoCellTec™

PhytoCellTec™ Malus Domestica is a liposomal active ingredient based on stem cells from the Uttwiler Spätlauber apple. This rare Swiss apple variety, derived from a seedling planted in the middle of the 18th century, was very famous for its excellent storability without shriveling. This explains why this active ingredient has been developed to exploit its youth secrets. Its action is based on the key role of skin stem cells on the quality of the skin. This booster active ingredient re-energizes the skin that regains its vitality.

### Oat sugar

As a 100% natural sugar tensor, this active ingredient is a purified fraction of polysaccharides from oat. This network of complex sugars of very high molecular weight adheres to the skin surface in a lifting, continuous and cohesive film that helps firm and tone the skin (In vitro tests).

### Sodium hyaluronate

Sodium hyaluronate in the presence of water is transformed into hyaluronic acid directly into the formula. Hyaluronic acid is naturally present in the skin and acts as a real sponge to attract and retain a significant amount of water. It plays an essential role in the integrity of the cutaneous structure and in the regulation of skin hydration. Sodium hyaluronate of very low molecular weight (100 to 130 kDA) is known for its high hydration power.

## RITUAL OF BEAUTY

Open the sachet and unfold the mask. Apply the ready-to-use mask to the face on perfectly cleansed skin. Hang the mask on the ears with the upper ear hooks and place the lower ear hooks on the ears again. Leave on for 15 minutes and remove the mask. Gently massage the excess serum.

Precaution for use: In case of eye contact, rinse with water.
