**CONSIGNMENT FOR A CAUSE**

Consignment is by appointment only at the boutique Tuesday, Wednesday or Thursday. We accept dresses, separates, accessories, handbags and jewelry in excellent, gently-used condition. All items must be no more than two years old, in current style, freshly laundered/dry cleaned, pressed and hung. We cannot accept any merchandise with the following defects: deodorant marks, stains or spots, missing buttons, broken or sticking zippers, pet hair, unpleasant odors, smoke, mildew, etc. We reserve the right to refuse any merchandise that does not meet the boutique's standards. All items must be authentic. We do not accept fake/faux designer items. If any item is later deemed to be misrepresented/unsuitable for sale, it will be rejected and donated to charity. LIMIT per consignment appointment: 25 gently loved garments, 5 like-new pair of shoes, 10 accessories

Consignment period is 90 days. Merchandise may not be withdrawn before the contract period has ended. Once the contract expires, consignors have five days to retrieve their unsold items. After the five days, all unsold items automatically become the property of Wear It Well to donate or liquidate. There will be no commissions paid on expired items. Please make note of the day you consign with us and the expiration date of your items. Should consignors decide to retrieve any expired items, a inventory list will be provided so that the consignors can locate their expired merchandise on our racks by their own individual account number. Tags will then be removed by management and account inventory adjusted to reflect any changes.

We have a consignor account fee of \$20, which must be paid in cash at your first appointment. The first 10% of every account fee will be donated to the Wear It Well water project. This charge is non-refundable.

Wear It Well will make all final decisions concerning merchandise pricing. Periodic markdowns will be based on inventory, condition and length of time on the sales floor and will be at the sole discretion of Wear It Well. An item fee of 10% will be added to all merchandise and donated to the Wear It Well clean water project. So for example the sales ticket for a garment priced at \$100 will appear as \$110. \$10 will be donated and the balance split equally between consignor/ store 50/50.

As items sell, funds will accrue in the WIW consignor's account and can be used at any time to make a purchase. Payout cheques for the previous month's sales are only issued when requested by the consignor. Requests must be received before the fifth of the month to ensure pickup after the tenth. Cheques will not automatically be mailed. After 90 days, any payments not picked up or cheques not cashed will be forfeited to Wear it Well. Accounts that remain inactive for a year will be closed. NOTE: We will not issue payout cheques for sales under \$20 unless you are closing your account.

All items are left at the owner's risk. While we will do our best to safeguard every item, Wear It Well assumes no responsibility for loss or damage to merchandise due to accident, fire, theft, vandalism, or any other cause.
