Consignor confirms that said items beings consigned are property, free of any encumbrances from any other parties. JbyG any future disputes in ownership.	-
Consignor agrees that unless express permission is granted cannot be posted for sale in any other website (this includes, but Craigslist, LoupeTroop, Diamond Bistro, and the like).	

Consignor understands that upon receipt of the item, JbyG will need approx. 4-6 weeks to properly prepare item for listing. Said item(s) undergo inspections, refurbishments, appraisal by a 3rd party, and professional photography.		
JbyG agrees, upon sale, to maintain the proceeds due to the Consignor separate and apart from its own funds and to deliver such proceeds, less commission, to the Consignor together with an accounting within 10 business days of the said sale.		
JbyG will remit proceeds via echeck, which will be sent via email to Seller. This will come in the form of a pdf document which may be downloaded, printed, and deposited like a regular check. Consignors who choose for proceeds to be sent via wire will incur a \$40 wire fee.		
Consignor agrees to accept lay-away sale transaction for their items. Items placed on lay-away are due for final payment on the 120th day after the deposit is received. Should buyer rescind the lay-away contract, Seller remits the accrued proceeds less its standard consignment fees to the Seller. Items will be placed back for sale on the website.		
Consignor agrees to include said item(s) to the bi-annual sales (Summer and Holiday), where reductions up to 10% will be posted. If consignor would like to reduce the price of their item at ANY TIME, they may send an email to cs@jewelsbygrace.com with specific instructions.		
Seller understands that while certain jewels sell immediately after being posted, such is not the case for a good majority of jewels, no matter the price point.		
JbyG agrees to accept as full payment a commission equal to the following schedule, and no other fees are to be charged unless as previously discussed with seller (certification fees, other misc fees).		

2024 CONSIGNMENT FEE SCHEDULE*

Items costing up to \$20,000 - \$750 or 25% of sale price, whichever is greater;

Items costing \$20,001 and up – Flat rate of 20% of sale price.
