#### PRODUCT DESCRIPTION

Each changing season causes dimensional stresses that can splinter and physically damage a wooden deck or dock.

Developed in Sweden to protect "CCA" pressure treated wood from the harsh Nordic weather, WOODguard SWO repels water, promotes wood stability, and highlights natural wood tones. It allows the wood to weather naturally to a beautiful driftwood gray color.

Treated lumber (often green in color) is often prone to rapid moisture gains and losses that cause warping and splitting in many wood species.

**WOODguard SWO** is a heavy-duty, transparent treatment designed especially for protecting new, "pressure-treated" wood. It does not form a film and will never crack or peel.

WOODguard SWO is a water repellent wood stabilizer that beautifully highlights natural wood tones. WOODguard SWO retards cupping, warping and splitting and generally minimizes physical deterioration caused by dimensional instability resulting from water absorption and extreme humidity changes. WOODguard SWO treatment also helps reduce nail corrosion and popping.

#### **DIRECTIONS FOR USE**

Apply by spray, brush or roller. **One moderate coat is sufficient.** Surfaces should be clean and free of all loose debris. Test before using. Do not use on painted surfaces. Avoid contact with plants, shrubs and trees.

**NEW DECKS & DOCKS:** Allow the deck or dock to dry for two to three months. Sweep to remove dirt and debris before application.

**WEATHERED, UNTREATED DECKS & DOCKS:** Make sure surface is free of all dirt and debris. If a new appearance is desired, clean with a pressure washer to remove the gray surface of wood. After washing, let the wood surface dry for three days before applying WOODguard SWO.

**WHEN PRESSURE WASHING:** To avoid wood damage, and achieve maximum effectiveness, make sure the pressure is set below 500 psi, and keep the nozzle of the power washer approximately one foot from the surface.

Apply to dry wood for maximum penetration and fastest drying. Do not over apply.

- WOODguard SWO penetrates into the wood with only a small portion evaporating. Do not apply to painted or otherwise sealed or highly dense surfaces. If in doubt, apply to a small test area. If the wood absorbs the treatment readily, it is suitable for use.
- WOODguard SWO does not "DRY" in the conventional sense. It cures into the wood. Blot up any excess WOODguard SWO left unabsorbed on the surface.
- 3. Coverage 250 300 sq. ft / gallon, depending on surface condition and wood porosity.
- Application temperature: Apply above 50°F. Hot weather promotes a faster cure time. Below 65°F, WOODguard SWO may become too viscous to spray.
- WOODguard SWO softens asphalt (including asphalt shingles)

- 6. Do not apply if rain is expected within 36 hours.
- 7. Avoid open flame during application and until the oil has thoroughly penetrated the treated surface.
- Any subsequent coating applied over WOODguard SWO must be tested on a remote area to verify compatibility before application. WOODguard SWO's highly water repellent system will repel latex coatings and may not be compatible with some oil or alkyd coatings. DO NOT TINT WOODguard SWO.
- 9. Until **WOODguard SWO** has thoroughly cured, treated area may be slippery.
- 10. WOODguard SWO may be applied to newly-constructed, pressure-treated decks that are thoroughly dry. Use only enough WOODguard SWO to be readily absorbed.

**CLEAN-UP:** Use detergent and water on fresh **WOODguard SWO** coated brushes, etc. If it has had time to cure, mineral spirits or paint thinner may be used for clean up.
