8.2 Exposure controls

Appropriate engineering controls

avoided, and effective local exhaust ventilation is not available, it is recommended that a dust respirator is worn, that is approved for use with lead dusts, and its type selected on the basis of the COSHH assessment, taking into account the Workplace Exposure Limit for lead in air.
