Limonene and natural products known to be rich in Limonene should only be used when the level of peroxides is kept to the lowest practical level. It is recommended to add antioxidants at the time of production of the raw material. The addition of 0.1% BHT or alpha-tocopherol for example has shown great efficiency.
Delta-3 Carene	13466-78-9	25	According to Amendment 28 to the Standards, IFRA recommend that essential oils and isolates (e.g. delta-3-carene) derived from the Pinacea family, including <b>Pinus</b> and <b>Abies</b> genera, should only be used when the level of peroxides is kept to the lowest practicable level, for instance by adding antioxidants at the time of production. Such products should have a peroxide value of less than 10 millimoles peroxide per liter, determined according to the
