Delta-3-Carene	13466-78-9	25	According to Amendment 28 to the Standards, IFRA recommend that essential oils and isolates (e.g. delta-3-carene) derived from the Pinacea family, including Pinus and Abies genera, should only be used when the level of peroxides is kept to the lowest practicable level, for instance by adding antioxidants at the time of production. Such products should have a peroxide value of less than 10 millimoles peroxide per liter, determined according to the FMA method. (Can be found on the IFRA website).
