Symptoms and effects - Following inhalation	- There may be shortness of breath and irritation of the throat and chest.
Symptoms and effects - Following skin contact	<ul> <li>Causes skin irritation.</li> <li>Prolonged or repeated contact with skin or mucous membrane result in irritation symptoms such as redness, blistering, dermatitis, etc.</li> </ul>
Symptoms and effects - After eye contact	- Serious eye damage/eye irritation
Symptoms and effects - After ingestion	- Burns may appear around the lips. Blood may be vomited. Bleeding may occur from the mouth/nose.
