Budget

- The revised 2015-16 budget was based on 229 students. We were aiming for 245 students and ended the year with 254 students. We are in good stead for our August audit.
- As of 5/31/16 we had received \$1,903,217 or 82% of our revised revenue budget. This compared to 87% received by 5/31 in 2014-15 and 85% received in 2013-14.
- As of 5/31/16 we had expended \$1,988,363 or 84% of our revised expense budget. This compared with 90% expended by 5/31 in 2014-15 and 88% in 2013-14.

We have 62 new students, bringing us to close to 300 students for Fall of

2016. Kindergarten through Grade 3 will be at our main campus, grades 4 - 8 will be at Grace Center. A letter to families about campus changes will be going out soon.

Next year's information form will request a parent email address for the Wednesday folder. We hope most families will provide an address to simplify the Wednesday communications. Kindergarten families will continue to receive a paper folder. Lunch bills will continue to go through the folders/regular mail. Staff will remind parents about benefit forms (school lunch) at curriculum night and also may communicate about available benefits through email.

Check register 4/12/16 – 6/8/16

Board reviewed checks written and asked for clarification of some vendors/payees and amounts. A motion to approve the check register was made by Vince Esades, seconded by Melissa Johnson and unanimously approved.

Journal entries 4/12/16 –6/8/16

Vince Esades moved approval of the journal entries, Barbara Glaser seconded. The motion was unanimously approved by the board.
