Zep Prevail is a dry, granular, concentrated deodorant/absorbent formulated specially to overcome objectionable odors of refuse and sewers. Absorbs liquids to prevent mess and slip hazards. Pound for pound Zep Prevail absorbs at least twice as much liquid as clay-based absorbents. Provides powerful, long-lasting and economical odor control under a wide variety of conditions. Imparts a pleasant fragrance to the entire treated area. Dust free. Contains 100% organic biodegradable materials.

DIRECTIONS:

In enclosed areas, sprinkle Zep Prevail where there is the least traffic. Use at the rate of about 2 oz. for each 1,000 cubic feet of enclosed space. To remove, simply sweep up and deposit in waste receptacle.

In outdoor areas scatter Zep Prevail widely over the entire area. The amount used will vary with the intensity of the odor problem. To keep garbage containers fresh and odor free, treat with 3 to 4 tablespoons Zep Prevail daily.

Scatter on truck beds, around the sides and over the contents of partially-loaded garbage and refuse trucks for complete odor control.

WARNING!

MAY CAUSE IRRITATION

FIRST AID:

SKIN: Immediately flush contaminated skin with plenty of water for at least 15 minutes. Get medical attention if irritation develops.

INHALATION: Move affected person to fresh air. Get medical attention immediately if irritation persists.

INGESTION: If this product is swallowed, DO NOT induce vomiting. If affected person is conscious, give plenty of water to drink. Get medical attention at once.

DISPOSAL AND/OR SPILL INFORMATION: As with all cleaning and maintenance procedures, run-off from the cleaning or maintenance process should be diverted to a collection vessel, or, where permitted, to a sanitary sewer (consult local and state regulations) and not allowed to soak into the ground or to enter a storm sewer. If this product is spilled or contaminated and cannot be used, creating the need for disposal, sweep up product and deposit in a sealable container. Rinse area well with water.

STORAGE: To seal out moisture, keep container tightly closed when not in use. Store in a dry area.
