

#### DIRECTIONS

Wet floor with water hose and then hand broadcast Zep X-1102 floor treatment uniformly over entire wet area. Allow to stand at least 10 minutes. Rinse thoroughly with potable water as needed in edible areas. Af desired, product may be allowed to remain on floor for an extended period of time in other designated areas./

#### WARNING!

CAUSES IRRITATION

Contact may produce skin and eye irritation. Potential skin sensitizer. Avoid contact with eyes and prolonged skin contact. Inhalation may cause respiratory tract irritation. Avoid inhalation of dusts. DO NOT swallow this product. Zep advocates limiting exposure to all chemical products. Zep recommends wearing goggles or safety glasses during product use and handling. The use of rubber, neoprene, nitrile, or other resistant gloves is recommended for prolonged use. Remove contaminated clothing promptly and DO NOT rewear until thoroughly cleaned. After handling, wash hands thoroughly with soap and water.

EYES: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.
