



Under Seat Amplifier Mounting Bracket for 2021-2022 Ford Bronco

Amplifier Mounting

Amplifier mounting holes are pre-drilled and threaded for select amplifiers listed below. Four M4x10 (3mm Allen) screws are supplied for mounting the amplifier. NOTE: When mounting different model amplifiers, it is recommended to temporarily install the bracket in the vehicle and determine a mounting position for the amplifier that will not interfere with the seat. For larger amplifiers, the wiring connections may need to be made before attaching the amplifier to the mounting bracket.

Installing the Mounting Bracket

For either side, the amplifier mounting bracket is placed under the front seat and secured using one front and one rear seat bolt (on the outboard side closest to the door). Once all amplifier connections and settings are made, attached the amplifier to the mounting bracket, align the the mounting bracket with the seat bolt holes and reinstall the seat and seat bolts. NOTE: If the seat is going to be unplugged and removed, always follow the vehicle manufacturers instructions for removing and re-installing the seat.
