Description of necessary first aid measures

Eye contact:

Immediately flush eyes with large quantities of water for several minutes, while holding eyelids apart. Remove contact lenses if easy to do so. Continue rinsing. Get medical attention if irritation or bonding occurs.

Skin contact:

Wash with soap and water. Peel or roll skin apart.

Ingestion:

Peel or roll skin apart. Adhesive becomes solid in contact with saliva and may adhere to inside of mouth. Saliva will lift adhesive in 1-2 days. Avoid swallowing solid adhesive after detachment. Not a toxic product.

Inhalation:

Remove to fresh air. Prolonged or repeated elevated exposure may cause allergic reactions with asthma-like symptoms in sensitive individuals.

Over-exposure signs/symptoms

Eye contact:

Immediately flush eyes with large quantities of water for several minutes, while holding eyelids apart. Remove contact lenses if easy to do so. Continue rinsing. Get medical attention if irritation or bonding occurs.

Skin contact:

Bonds skin in seconds. May cause skin irritation. May cause sensitization by skin contact. Cyanoacrylates generate heat on polymerization, so very large amounts will burn the skin.

Ingestion:

Adhesive becomes solid in contact with saliva and may adhere to inside of mouth. Saliva will lift adhesive in 1-2 days. Not a toxic product.

Inhalation: Prolonged or excessive inhalation may cause respiratory tract irritation.

Acute Effects: Avoid exposure to vapor concentration in confined areas.

Chronic Effects: Frequent or prolonged contact may irritate the skin and cause a skin rash (dermatitis).
