The Trimble Civil Engineering and Construction division is pleased to announce that a patch of version 3.74 of the Trimble SCS900 Site Controller Software is now available. This patch version can be identified by the full version number of: 3.74.18301.18 that is visible on the software splash screen and via the Menu > Settings > System Info.

This version is available, at no charge, to all users under active or extended warranty. It is a purchasable upgrade for all users outside warranty.

The software and its modules can be loaded through Trimble Installation Manager (TIM), which can be downloaded from http://www.trimble.com/installationmanager/.

Trimble TSC3 Controller and Trimble Site Mobile Installation

After connecting the TSC3 or Site Mobile controller using a USB cable to a computer that is connected to the Internet and running TIM, SCS900 and all the purchased modules as well as the controller activation will be downloaded to the controller.

Trimble Site Tablet, Trimble Site Tablet 10, Trimble T10 Tablet, and Trimble TSC7 Installation

For the Trimble Site Tablet, Site Tablet 10, T10 Tablet, and TSC7, TIM needs to be installed and run directly on the device and the device connected to the internet. The License Manager checks which software options were purchased for the specific controller with this serial number and checks for the latest version of the software that is available.
