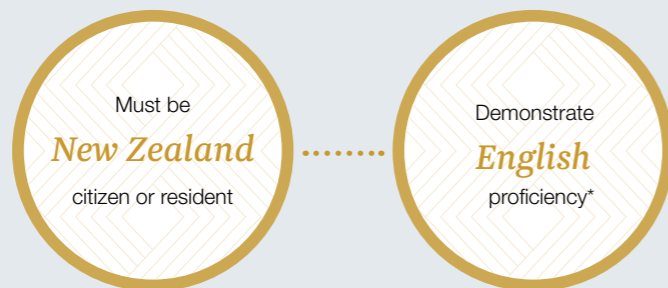
Governance for Financial Advice Providers (Small Business) (Level 6)

- how to 'right size' your governance framework;
- when to have a board and how to get value from directors;
- how to conduct meaningful board meetings and produce board papers and meeting minutes quickly; and
