# RADAR: YOUR ONE STOP CPD SOLUTION

### What is Radar?

Radar is Strategi Institute's online platform for the administration, documentation, tracking, reporting, and delivery of training. It is designed to be a one-stop solution for continuing professional development (CPD), for financial and professional services, and AML reporting entities.

Radar is highly customisable and is used by many New Zealand financial service organisations including BNZ, Pinnacle Life and many more. It contains a 'library' of over 300 CPD training modules plus functionality for professional development plans (PDPs), CPD logs and other training records.

Radar keeps all your data secure. It meets the standard security protocols demanded by banks and insurance companies. Radar is hosted by Catalyst, who meets the [NZ government security requirements](#).

Radar is suitable for all businesses that require a learning management system to manage and track staff, and contractors who require ongoing training and CPD. It is also used as the online education portal for the New Zealand Certificate in Financial Services Level 5 courses and all the Strategi Institute specialist micro-credential courses.

### What are Radar's benefits?

Radar's multiple benefits include:

- An ever-growing library of CPD modules - enabling you to choose a wide variety of CPD modules to meet all your training needs.
- Dedicated staff to answer your queries, develop new content and ensure all published content is current.

### How does Radar work?

Radar is the 'command centre' for training resources, professional development plans (PDP) and CPD training logs.

Radar holds online training and assessment content for CPD. Training content is presented in a range of formats (e.g. PDF, PPT, video etc.), with assessment for CPD via brief multi-choice and multi-option tests. Radar can deliver interactive training content such as interactive videos, memory games, image hotspots, branching scenarios, and much more.

When CPD training is completed within Radar, the results are automatically populated into the user's CPD log allowing both the user and management to track progress.

Staff can be assigned training by designated training managers, and staff progress monitored. Standard reports are available plus customised reporting can be organised.

# RADAR SUBSCRIPTION OPTIONS AND PRICING

### Radar: full subscription

A full annual subscription provides the platform functionality, plus unlimited access to over 300 CPD articles - this works out to be less than \$1 per article. The benefit of the full subscription is you get instant access to all new and updated content that is added to Radar. The standard full subscription pricing is based on the number of users in an organisation.

### Radar tenancy subscription

A tenancy is a private space on Radar for organisations to set up and host their own content. This subscription is beneficial for larger businesses as it:
