

# Back-To-New Grout Cleaner

## TECHNICAL DATA SHEET



### PRODUCT BENEFITS:

- Proprietary Surfactants “lift” Below Surface Contaminates.
- Restores Dirty, Neglected Grout to Like New Appearances.
- Equally Effective on Cement, Epoxy and Urethane Grout.
- Buffered Acids Dissolve Ground-In Dirt and Stains.

### USES:

- Cement, Epoxy and Urethane Grout.
- Can also be used to make dirty neglected ceramic, porcelain and quarry tile look new.
- Removes contaminants and stains from Food & Beverage Stains, Grease, Soap Scum, Minerals and Hard Water Deposits, Ground-in Dirt & Soil and more.
- Prepares Grout Joints for the Application of Grout Re-Coloring Sealer and Grout Sealer.
- Interior and Exterior applications.

### DIRECTIONS:

Read entire label before using. Use only as directed. Always test in a small inconspicuous area to determine ease of application and desired results (see Limitations below).

### APPLICATION STEPS:

1. Sweep or vacuum surface to be cleaned to remove any loose contaminants.
2. Apply **Back-To-New Grout Cleaner** liberally with trigger spray bottle.  
Expert Tip: For large projects, it is recommended that the working area be divided into manageable sections of approximately 25 sq. ft.
3. Allow **Back-To-New Grout Cleaner** to dwell on surface for 5 to 10 minutes. Make sure product does not dry on the surface. If needed, apply additional product on the surface
4. Agitate with a Primo Tools™ White Nylon Scrub Pad or other comparable non-marring scrubbing tool until surface is clean.
5. Thoroughly rinse surface with water. A wet/dry vacuum may also be used.
6. Some surfaces may require additional applications.  
Expert Tip: High-pressure (1000-3000 psi) sprayers are highly effective at rinsing away stains when used in conjunction with **Back-To-New Grout Cleaner**.
7. Wipe surface completely dry using a clean, dry, white cotton or micro-fiber towel.
8. If surface is to be sealed, allow 24 hours drying time prior to applying a high quality OMNI sealer (see OMNI Product Recommendation Guide).  
Expert Tip: Should **Back-To-New Grout Cleaner** fail to provide desired results to severely discolored grout due to years of neglect, **OMNI Grout Re-Coloring Sealer** is recommended.

### SIZES:

32 oz. Trigger Spray (other sizes available by special order).

### COVERAGE:

Approx. 33 to 100 sq. ft. (3.1m<sup>2</sup> to 9.3m<sup>2</sup>) per 32 ounces depending on the type of surface, porosity, texture, temperature and method of application.

### COMPLIANCE AND HANDLING:

- Complies with all Federal, State and Local VOC regulatory requirements.
- Use and store between 40°F and 100°F (4°C and 38°C).
- Store in original container only and close after each use.
- Shelf life expected to be at least 1 year.

### LIMITATIONS:

- May etch, lighten, or alter the color of cement-based surfaces, metal, natural stone (such as marble, limestone and other acid sensitive stones) and tile.
- Do not mix with ammoniated cleaners or bleach as harmful fumes may result.
- Prevent product from contacting surrounding surfaces such as carpet, glass, landscaping, metal, paint and wood.

### WARNINGS:
