### FORM 10 OFF-LICENCE

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

**PURSUANT** to the Sale and Supply of Alcohol Act 2012 (the Act), **Rock Ferry Wines Limited** (the licensee) is authorised to sell alcohol on the premises situated at 80 Hammerichs Road Rapaura, Marlborough District and known as "**Rock Ferry Wines Cellar Door**", to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### CONDITIONS

- (a) No alcohol is to be sold or delivered on Good Friday, Christmas Day or before 1.00 pm on Anzac Day.
- (b) No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made-
  - (i) On the premises; or
  - (ii) From grapes or fruit harvested from land on which the premises are situated.
- (c) Alcohol may be sold or delivered on the following days and during the following hours:

Cellar Door- Monday to Sunday 9.00 am to 10.00 pm

Remote sales- at any time on any day however the days and hours within which alcohol that has been sold may be delivered is restricted:

No alcohol sold is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day, or at any time after 11.00 pm on any day and before 6.00 am on the next day.

- (d) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (e) The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible consumption of alcohol.
- (f) The licensee, when conducting phone, mail, internet sales (remote sales) must ensure that all the requirements under Section 59 of the Act relating to remote sales are complied with.
- (g) The tasting room is designated as a supervised area.

# **DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S**

A copy of this licence must be displayed at the principal entrance to the premises. The entrance into the tasting room is designated as the principal entrance.

#### **DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) either-
  - (i) Until the close of the period for which it was last renewed; or
  - (ii) If it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either(i) until the close of the period of 3 years after the period for which it was last renewed: or
  - (ii)if it has never been renewed, until the close of the period of 4 years after the day it was issued.

### FORM 9 ON-LICENCE

Sections 14 to 16 and 64, Sale and Supply of Alcohol Act 2012

**PURSUANT** to the Sale and Supply of Alcohol Act 2012 (the Act), **ROCK FERRY WINES LIMITED** (the licensee) is authorised to sell and supply alcohol on the premises/conveyance situated at 80 Hammerichs Road Rapaura, Marlborough District and known as "**Rock Ferry Wines Cellar Door**", to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not present on the premises to dine.
- (b) Alcohol may be sold on the following days and during the following hours:

  Monday to Sunday 9.00 am to 1.00 am the following day, EXCEPT THAT on the Thursday before Good

  Friday; and on Easter Saturday; and on Christmas Eve; and on the day before Anzac Day, alcohol may
  only be sold between 9.00 am and 12.00 midnight.
- (c) A range of food choices must be readily available at all times that the premises are open. Menus must be visible and food should be actively promoted. A minimum of three types of food should be available. The range or style of food will be as shown on any menu submitted. Alternatively the range of food should include such items as paninis, pizzas, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls, and/or salads.
- (d) The licensee must ensure that at all times the premises is open for the sale and supply of alcohol, there is available for sale and consumption on the premises, at reasonable prices, a reasonable range of non-alcoholic drinks.
- (e) Free drinking water must be available at all times.
- (f) The licensee must ensure there is available for sale and consumption on the premises low alcoholic drinks containing not more that 2.5% ethanol by volume at 20 C.
- (g) The licensee must ensure that there is available to customers, free, comprehensive and accurate information about the forms of transport from the premises.
- (h) The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible consumption of alcohol.
- (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (j) The tasting room is designated as a supervised area.
