Approval – Dangerous Goods Training Course

1 Application

This instrument applies to Dangerous Goods Training International [ARN: 825673], the training course materials submitted to CASA (the **training course**) and persons who undertake the training course (the **employees**).

2 Approval

The **training course** is approved as being appropriate for;

- a) Group A employees;
- b) Group B employees;
- c) Group F employees;
- d) Employees with a combination of responsibilities as Group A, B or F employees.

as per the matrix/matrices contained in Schedule(s) 1 and 2.

3 Conditions

- a) Changes to the Civil Aviation Act 1988, the Civil Aviation Safety Regulations 1998, the International Civil Aviation Organization - Technical Instructions for the Safe Transport of Dangerous Goods by Air, and the International Air Transport Association - Dangerous Goods Regulations, in force from time to time, must be reflected, as applicable, in the course material and CASA must be notified in writing of the changes made.
- b) This approval is subject to a satisfactory standard being maintained.
- c) Where any course is limited to certain DG Class/Hazard Divisions, then those workbooks, promotional material and certificates of training are to reflect those limitations.
- d) The course Approval holder is required to keep records of courses, students and instructors for a minimum period of 36 months from the completion of the course.
- e) The course approval holder is to make training records available to CASA.
- f) In the event that the course approval holder ceases to trade then an electronic record of the last 36 months of training records is to be submitted to CASA.
- g) CASA may revoke this approval if it is necessary in the interests of the safety of air navigation.

4 Date of Operation

This Instrument expires at the end of **December 2019**
