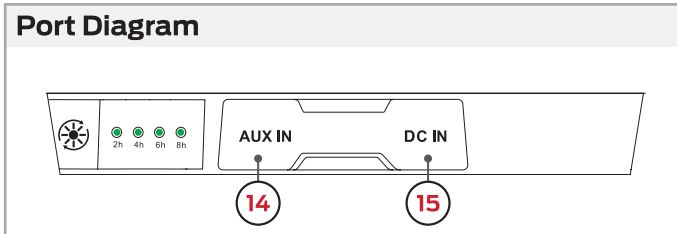
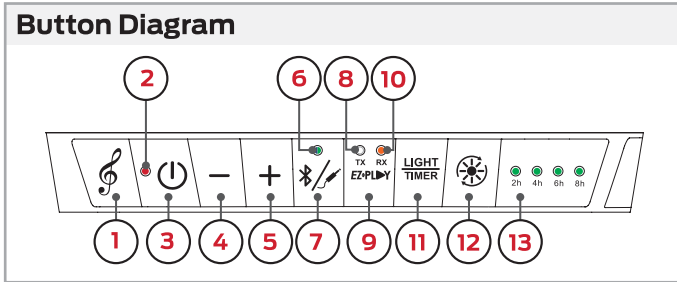

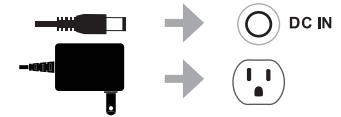

# POWER

**IMPORTANT:** Before first use, charge for ~6 hours.

## Charging

1 **CONNECT** the speaker to an external power source using the included DC power cable.



While **CHARGING**, the **RED** LED indicator will double blink quickly.



When **FULLY** charged, the **RED** LED indicator will stay on.



When **LOW**, the **RED** LED indicator will flash rapidly. (*twice a second*)



**Full Charge** – achieved in 4 hours while powered OFF.  
– achieved in 11 hours while powered ON.

## Power

1 Press the **POWER** button to turn the speaker **ON**.



*The **RED** LED next to the power icon will turn on for 3 seconds.*




Press and hold the **POWER** button, 5 seconds, to turn the speaker **OFF**.




# AUDIO


## Bluetooth Pairing

**1** Place your smart device within **3 FEET** of the speaker. 

Make sure *Bluetooth* is enabled on your device. 


**2** **Bluetooth mode** is automatically entered when speaker is powered on (*BLUE LED Bluetooth & EZ-Play TX LED will quickly flash*). 

The speaker will make audible confirmation. **"Bluetooth"**


**3** **HOLD** Bluetooth button for ~3 seconds to **Pair** (*BLUE LED Bluetooth & EZ-Play TX LED will quickly flash*). (Hold ~3 sec.)  **"Bluetooth Pairing"**


**4** Select **"MONSTER TORCH"** on your smart device to pair with the speaker. 


Speaker will confirm connection with audible sound (*BLUE LED turns solid*).  **"Bluetooth Connected"**


 **~30 feet max connection range after pairing.** Devices out of range may suffer disruption or loss of signal.


## EZ-Play Pairing


**1** **BLUETOOTH PAIR** smart device to **TORCH** speaker. (See Bluetooth Pairing)  **"Bluetooth Connected"**

**2** **HOLD** the EZ-Play Pairing Button in TX (transmitting) mode for ~2 seconds to select speaker as audio transmitter. (*TX White LED will begin to flash rapidly*). (Hold ~2 sec.) 


**3** **PAIR** a RX (receiving) EZ-Play speaker by setting it to Bluetooth mode. (*DO NOT pair Bluetooth*)  **"Bluetooth"**

**4** **SELECT RX** mode by using the EZ-Play Button. (Press)  **"RX EZ-PLAY"**

**5** **HOLD** the EZ-Play Button for ~2 seconds to search for an TX (*transmitting*) unit. (*Amber LED will blink rapidly*) (Hold ~2 sec.)  **"RX EZ-PLAY"**

▪ **CONNECT** up to 7 more EZ-Play units by repeating steps 2-5, totaling up to 8. (Repeat 2-5) 

## AUX IN

▪ Plugging in a 3.5mm cable into the AUX input will automatically turn off the Bluetooth function and switch the speaker to AUX. (Connect) 

Speaker will confirm connection with audible sound (*GREEN LED turns solid & EZ-Play TX LED will quickly flash*).  **"AUX IN"**

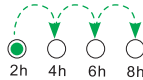
# FEATURES

## Timer Setting

- HOLD** (~3 sec.) the **Timer/Light Button** to select the next timer duration: **2** hours, **4** hours, **6** hours, or **8** hours.

(Hold ~3 sec.) 

*(LED corresponding to timer length will light up solid Green. Repeat step for each time duration change.)*



## Light Modes

- PRESS** the **Light Mode Button** to turn on the ambient light.

(Press) 

*(Reverts to last selected mode when turned on. Will also function when the speaker is off.)*

- PRESS** the **Light Mode Button** to cycle through the modes: OFF, Flicker, Pulse, **STEADY**, and Gravity.

(Press)    
 Off → Flicker → Pulse → Steady → Gravity →

- In **STEADY** mode (only), press the **Timer/Light Button** to adjust the strength of the light: 0%, 20%, 40%, 60%, 80%, and 100%.

(Press)  

0% → 20% → 40% → 60% → 80% → 100% →

- HOLD** (~3 sec.) the **Light Mode Button** to turn off the ambient light in any mode.

(Hold ~3 sec.) 

## Zen Mode

- HOLD** the **Zen Mode Button** (~3 seconds) to start music in any mode.

(Hold ~3 sec.) 

- PRESS** the **Zen Mode Button** to cycle through song selection. Including: Waves, Nature, Ocean Serenade, Piano Ballad and Soft Piano.

(Press)  

Waves → Nature → Ocean Serenade  
 → Piano Ballad → Soft Piano →

- REPEAT** step one to exit Zen music mode.

(Hold ~3 sec.)

<b>Speaker is not powering on</b>	<ul style="list-style-type: none"> <li>Make sure DC POWER adapter is fully inserted into the unit (<i>See pg. 1</i>)</li> </ul>
<b>Buttons are not responding</b>	<ul style="list-style-type: none"> <li>Reset the speaker by turning the power OFF, and then back ON. (<i>See pg. 1</i>)</li> <li>Unplug the DC POWER adapter, then plug it back in. (<i>See pg. 1</i>)</li> </ul>
<b>No music is playing</b>	<ul style="list-style-type: none"> <li>Make sure the speaker is set to the same source as your audio device. If you are playing audio via AUX IN jack, make sure the speaker is in AUX IN mode, etc. (<i>See pg. 2</i>)</li> <li>Make sure the VOLUME level is high enough on your audio device as well as the speaker.</li> </ul>

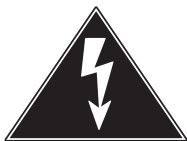
