Stain Resistance Warranty Coverage

Clubhouse with Sunshield and Korelite Technology is designed to resist staining for a period

of twenty-five years when applied to a residential application. While no product is stain-proof, Clubhouse does provide a high level of stain resistance to permanent stains resulting from spills of common food and beverage items including: wine, tea, coffee, fruit punch, soda, ketchup, mustard, salad oils, barbecue sauce and other food or beverage items that would typically

be in use on a residential deck. When exposed to spills from these items the deck should be cleaned with mild soap and water no longer than one week after the spill has occurred. Materials not covered by the stain resistance warranty include but are not limited to abrasive compounds of acidic or basic pH, strong solvents, oil and water-based paints or stains, acetone, methylethylketone, mineral spirits, petroleum ether, toluene, xylenes, methylene chloride, metallic rust, spray sunscreen or other abnormal contact from items not connected with a residential deck.
