APPLICATION

Remove the protection, put the band on the support avoiding the formation of air bubbles between the butyl and the support.

For joints superimpose the products of at least 5 cm.

The non-woven support can be repainted but, given the extreme flexibility of butylic mastic, the painted layer, covering the non-woven could present light cracks. The covering, adhesives or paints which cover the non-woven must be compatible with it. Butylic mastic is susceptible to solvents.
