All non-skin contact, including: Air Fresheners and fragrancing of all types (excluding aerosol products): plug-ins, solid substrate, membrane delivery; Toilet blocks; Joss Sticks, Incense; Insecticides (mosquito coil, paper, electrical, etc...excluding aerosols); Plastic articles (excluding toys); Candles; Fuels; Paints; Floor wax; Liquid refills for air fresheners (cartridge system)	Class 11.A
All incidental skin contact, including: Machine Dish wash Detergents and Deodorizers. Machine only Laundry Detergents (e.g. liquitabs) Deodorizers/Maskers (e.g. fabric drying machine deodorizers, carpet powder) Pot pourri, fragrancing sachets, liquid refills for air fresheners (non-cartridge systems), etc...
