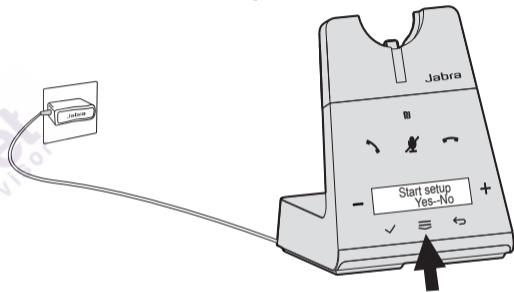
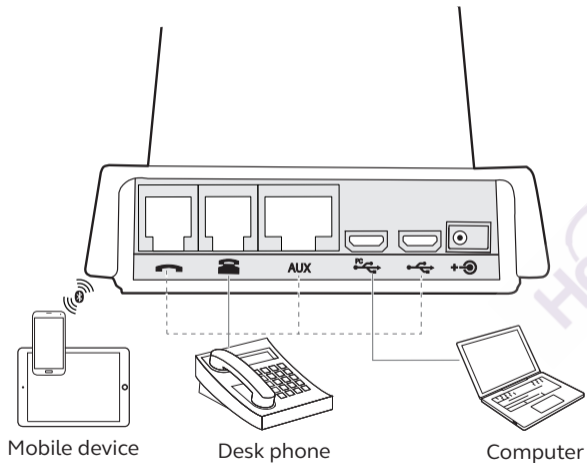

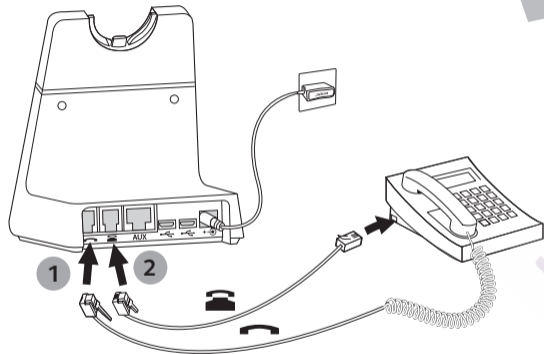


Plug the base into a power supply, and then follow the set up instructions on the screen.

The set up instructions will help you connect to your computer, mobile device or desk phone. For desk phones, first connect all the cables (refer to the following pages).

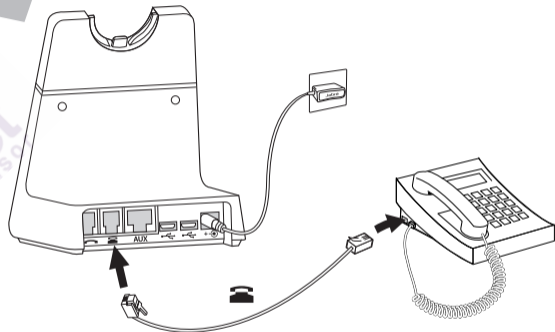
