(a) the manufacturer's recognized name, trademark, or other mark as well as the model number; or (b) in the case of private labeling, the name, trademark, or other mark of the customer for whom the fitting was manufactured as well as the model number.

The faucet and/or the faucet packaging shall be marked with the maximum flow rate in gpm and L/min and the EPA WaterSense logo.

Marking shall be in gpm and L/min in two-digit resolutions (e.g., 1.5 gpm [5.7 L/min]).
