"Tuner Cult Giveaway #13" OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The "Tuner Cult Giveaway #13" (the "Sweepstakes") is intended for legal residents of the United States of America (USA) or Canada and shall only be construed and evaluated according to U.S. law and Canadian law. Do not enter this Sweepstakes if you are not located in the USA or Canada at the time of entry. By participating, Entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes. 1). Online: Entrants who purchase online will receive one (1) entry for each \$1.00 of merchandise purchased (excluding tax and shipping) in the Tuner Cult online store (each, an "Online Store Entry"). All online entries must be received by 11:59:59 p.m. PT on August 9, 2020. One purchase per day to receive Sweepstakes entries allowed. Throughout the Promotion Period, the Sponsor may announce Bonus Entries on www.tunercult.com and/or on its social media pages, opportunities to earn additional entries ("10X") entries ("Bonus Entry Periods").

To earn 10X entries: Earn ten (10) entries for every \$1.00 spent at www.tunercult.com (10X Entry Period).

Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of an entry. Internet entries must be made by the Entrant only at the Website.
