

**“Tuner Cult Giveaway #21”
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The “Tuner Cult Giveaway #21” (the “Sweepstakes”) is intended for legal residents of the United States of America (USA) or Canada and shall only be construed and evaluated according to U.S. law and Canadian law. Do not enter this Sweepstakes if you are not located in the USA or Canada at the time of entry. By participating, Entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes. Winning the Prize (as described below) is contingent upon fulfilling all requirements set forth herein.

Employees, officers and representatives of the Sponsor, the Administrator, their respective parent companies, employees, officers, directors, subsidiaries, affiliates, distributors, sales representatives and advertising and promotional agencies, and the officers, directors, agents, and employees of each of the foregoing, and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above (collectively, the “Released Parties”) are NOT eligible to participate in this Sweepstakes. Non-eligibility or non-compliance with any of these Official Rules will result in disqualification. **Void in Puerto Rico, U.S. territories, and where prohibited or restricted by law.** (For the avoidance of doubt, any references in these Rules to Entrants shall also include the Entrant who is deemed the Winner (as defined below)).

TWO WAYS TO ENTER: The Sweepstakes begins at 12:00:01 a.m. Pacific Time (“PT”) on April 16, 2021 and ends at 11:59:59 p.m. PT on May 16, 2021 (“Sweepstakes Period”). The Sponsor’s computer is the official time-keeping device for the Sweepstakes.

1). Online: Entrants who purchase online will receive one (1) entry for each \$1.00 of merchandise purchased (excluding tax and shipping) in the Tuner Cult online store (each, an “Online Store Entry”). All online entries must be received by 11:59:59 p.m. PT on May 16, 2021.

Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of an entry. Internet entries must be made by the Entrant only at the Website. Entries made by any other individual or any entity, and/or originating at any other web site or email address, including, but not limited to, commercial Sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of automated entry devices is prohibited, and no mechanically reproduced entries are allowed; all such entries are void.

2). In the event of a dispute as to the identity of a Winner based on an email address, the winning entry will be declared by the authorized account holder of the email address submitted at time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

The potential Prize Winner will be notified by the Administrator via phone, email and/or USPS mail, or other home delivery service of Sponsor's choice.

PRIZE: The **PRIZE WINNER** ("Winner") upon the Administrator's confirmation of eligibility. winner will receive a NEW Customized 2021 Toyota Supra GR which has an approximately retail value ("ARV") USD \$60,000 and \$40,000 cash award ("Prize" or "Grand Prize"). Total Prize Pool \$100,000.
