

TUNER CULT GIVEAWAY #1
OFFICIAL RULES
NO PURCHASE NECESSARY. PURCHASE OR ACCEPTANCE OF
A PRODUCT OFFER WILL NOT IMPROVE YOUR CHANCES OF WINNING

1. **ELIGIBILITY:** The Tuner Cult Giveaway #1 (the "Giveaway") is open only to legal residents of the 50 United States and the District of Columbia, who are licensed drivers, 18 years of age or older (or legal age of majority in the state in which they reside). If a purchase is returned prior to the Giveaway drawing, entry will be voided. Your purchase transaction must be received by 11:59:59 PM PT January 22, 2019 to be eligible to receive entries.
 - B. Mail-in Entry: To enter without making a purchase, on a plain piece of 3"x5" paper, hand print your first and last name, street address city, state/province, zip/postal code, date of birth (mm/dd/yyyy), e-mail address plus daytime telephone number including area code.
