DIY Refill Instructions Botanical Bug Spray

MAKE OR REFILL YOUR OWN BOTANICAL BUG SPRAY!

EQUIPMENT NEEDED TO MAKE ONE 4-OUNCE BOTTLE:

- (1) 10ML BOTTLE OF HAZEL MOON BOTANICALS 100% NATURAL UNDILUTED BUG SPRAY BLEND OR
 - (1) 7ML BOTTLE OF K9 BLEND
 - (1) 4OZ ALUMINUM OR GLASS SPRAY BOTTLE
 - SMALL FUNNEL
 - 5ML (1 TSP) MEASURING SPOON
 - MEASURING CUP
 - 4 TSP (20ML) 91% RUBBING ALCOHOL OR VODKA OR OTHER UNFLAVORED ALCOHOL
 - WITCH HAZEL OR DISTILLED WATER OR CARRIER OIL OF CHOICE IF MAKING A ROLL ON

DIRECTIONS FOR 4OZ BOTTLE:

1. WIPE DOWN YOUR BOTTLE, WORK AREA, AND ANY UTENSILS USING RUBBING ALCOHOL OR VODKA.
2. MEASURE 4 TSP (20ML) OF PREFERRED ALCOHOL INTO BOTTLE
3. CAREFULLY OPEN ESSENTIAL OIL BOTTLE, REMOVING ORIFICE REDUCER. POUR ENTIRE CONTENTS OF ESSENTIAL OIL BOTTLE INTO SPRAY BOTTLE.
5. MEASURE 3 OZ (90 ML) OF WITCH HAZEL OR DISTILLED WATER AND ADD TO BOTTLE.
6. WRITE DOWN DATE MADE.
7. SHAKE WELL AND USE!

DIRECTIONS FOR 8OZ BUG SPRAY:

USING AN 8OZ SPRAY BOTTLE, DOUBLE ALL INGREDIENTS LISTED ABOVE, INCLUDING (2) BOTTLES OF HAZEL MOON BOTANICALS UNDILUTED BUG SPRAY OR K9 ESSENTIAL OIL BLEND.

DIRECTIONS FOR 10ML OIL BASED ROLL ON:

ADD 10 DROPS OF UNDILUTED BUG SPRAY ESSENTIAL OIL BLEND TO A 10ML ROLLER BOTTLE, THEN FILL TO BASE OF NECK WITH CARRIER OIL OF CHOICE. THIS RESULTS IN A 5% DILUTION. BE SURE NOT TO FILL OIL PAST THE POINT WHERE THE BOTTLE NARROWS, AS THE OIL WILL OVERFLOW WHEN YOU INSERT THE ROLLER.

WARNINGS: FOR EXTERNAL USE ONLY. AVOID SPRAYING IN EYES. DO NOT APPLY DIRECTLY TO SKIN ON CHILDREN UNDER 2 YEARS OF AGE. DISCONTINUE USE IF SKIN BECOMES IRRITATED. CONSULT A PHYSICIAN IF NURSING OR PREGNANT. BOTANICAL BUG SPRAY NOT FOR USE ON DOGS OR CATS. K9 BUG SPRAY CAN BE USED ON DOGS AGE 6MONTHS+, AND PEOPLE TOO!

PURPOSE: TO REPEL MOSQUITOS, BITING FLIES, AND TICKS. DIRECTIONS FOR USE: APPLY PROPERLY DILUTED PRODUCT TO AREAS COMMONLY EXPOSED TO BITING INSECTS, SUCH AS BEHIND EARS, BACK OF KNEES, AND ANKLES. FOR BEST RESULTS, REAPPLY EVERY 2-3 HOURS. HAZEL MOON BOTANICALS REPRESENTS THAT THIS PRODUCT QUALIFIES FOR EXEMPTION FROM REGISTRATION WITH THE EPA UNDER FIFRA 25b.
