- Parabens
- Phthalates (DBP, DEP, DMP, BBP)
- SLS (sodium laureth sulfate)
- PEG (propylene glycol, polyethylene glycol)
- BHA/BHT
- DEA (diethanolamine)
- Petrochemicals
- Formaldehyde
- Synthetic Fragrance (Parfum)
- Benzoyl peroxide
- Triclosan
- Coal tar dyes (dandruff shampoo)

**Your skin is the largest organ of your body.**

It serves many functions including helping you to detox, – rid toxins out of your body through your skin via sweating. It also communicates with the environment to balance the body's circadian rhythm. (These are two reasons not to put SPF on your entire body all day, every day. Would you wrap your liver in plastic?
