It is required to have RMA (Return Merchandise Authorization) number issued by BeauWIGful prior to return any items. A customer must contact us in **5 business days** of the delivery by email at info@beauwigful.com to receive RMA number. All returns must be postmarked within 5 days from the date RMA issued. RMA numbers must be clearly marked on the outside of the shipping box. An additional fee may be charged for the unauthorized return or late returns. Shipping cost (including Free Shipping Promotions when purchasing) will be deducted from your refund/exchanges. Customers are responsible for shipping costs. Refund/Exchange can take up to 10 business days.
