- Do not perform modification to the fixture.
- · Do not touch the fixture when switched on.
- This fixture is not dimmable.
- Red LED indicates charging state of battery: LED on indicates Charge; LED off indicates loss of a.c. power.
- Inspection and maintenance must be performed in accordance with AS/NZS2293-2.
- The battery must be replaced when the unit no longer meets rated operating life.
- Ensure battery is kept as far as possible from lamp and heat sources when installed.
- Failure to follow these instructions will void the warranty.

This electrical product should not be disposed as normal waste. Please always recycle! Check with your Local Council about your recycle options.



Installation Instructions:

- 1. Ensure mains supply is switched OFF.
- 2. Unpack the fixture and accessories carefully and place on a flat surface. Dispose all packaging material thoughtfully.
- 3. Drill mounting holes and cable entry hole into the mounting surface using bracket (A) as a template.
- 4. Secure bracket (A) to the mounting surface using screws (B). Rawl plugs (C) need to be used for concrete mounting surface.
- 5. Run mains wire through the cable entry hole and connect the Live (L), Switched Live (SL), Neutral (N) and Earth according to the markings on the terminal block. Make sure the connections are firm and secure.
- 6. Secure the fitting (E) to the bracket (A) using screws (F).
- 7. Turn the power on. The Status LED will light up indicating control gear is on.
- 8. When the power is disconnected the Emergency LED will light up and be powered by the battery.
- 9. Pressing the test switch will simulate a power outage.
- 10. Allow a minimum of 16 hours charge time for initial charge.
