masks not used as medical device; Fertilizers, solid (pellet or powder)

IFRA Category 12 Products not intended for direct skin contact, minimal or insignificant transfer to skin: Candles of all types; Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods);
