IFRA Category 1 Products applied to the lips: Lip products e.g., lipstick, lip balm; Children's toys IFRA Category 2 Products applied to the axillae: Deodorant and antiperspirant products of all types; Body sprays/mists **IFRA Category 3** Products applied to the face/body using fingertips: Eye products e.g., eye make-up, eye moisturizer; Facial make-up; Make-up remover; Nose pore strips; Wipes for face, neck, hands, body; Facial masks; Body and face paint IFRA Category 4 Products related to fine fragrance: Hydroalcoholic and non-hydroalcoholic fine fragrance of all types e.g., Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, aftershaves of all types; Ingredients of perfume and fragrance mixtures for cosmetic kits; Scent pads; Scent strips IFRA Category 5A Body lotion products applied to the body using the hands (palms), primarily leave on: Foot care products e.g., creams, powders; Insect repellent for application to the skin; All powders and talc (excluding baby powders and talc) IFRA Category 5B Face moisturizer products applied to the face using the hands (palms), primarily leave on: Facial toner; Facial moisturizers and creams IFRA Category 5C Hand cream products applied to the hands using the hands (palms), primarily leave on: Hand cream; Nail care products including cuticle creams; Hand sanitizers IFRA Category 5D Baby creams, baby oils and baby talc: Baby cream/lotion, baby oil, baby powders and talc IFRA Category 6 Products with oral and lip exposure: Toothpaste; Mouthwash, including breath sprays; Toothpowder, strips, mouthwash tablets IFRA Category 7A Rinse-off products applied to the hair with some hand contact: Hair permanent or other hair chemical treatments (rinse-off) e.g., relaxers, including rinse-off hair dyes IFRA Category 7B Leave-on products applied to the hair with some hand contact: Hair sprays of all types e.g., pumps, aerosol sprays; Hair styling aids non sprays e.g., mousse, leave- on conditioners; Hair permanent or other hair chemical treatments (leave-on) e.g., relaxers, including leave-on hair dyes; Shampoo - Dry (waterless shampoo); Hair deodorizer **IFRA Category 8** Products with significant anogenital exposure: Intimate wipes; Tampons; Baby wipes; Toilet paper **IFRA Category 9** Products with body and hand exposure, primarily rinse off: Bar soap; Liquid soap; Shampoo of all type; Conditioner (rinse-off); Body washes and shower gels of all types; Baby wash, bath, shampoo; Bath gels, foams, mousses, salts, oils and other products added to bathwater; Cleanser for face (rinse-off); Shaving creams of all types e.g. stick, gels, foams; All depilatories (including facial) and waxes for mechanical hair removal; Foot care products (feet are placed in a bath for soaking); Shampoos for pets IFRA Category 10A Household care excluding aerosol / spray products: Hand wash laundry detergent; Laundry pretreatment of all types e.g. paste, sprays, sticks; Machine laundry detergents with skin contact e.g. liquids, powders; Fabric softeners of all types including fabric softener sheets; Ironing water; Hand

dishwashing detergent; Hard surface cleaners of all types e.g. bathroom, kitchen cleansers, furniture polish; Toilet seat wipes; Household cleaning products, other types including fabric cleaners, carpet cleaners, furniture polishes sprays and wipes, stain removers, treatment products for textiles e.g. starch sprays; Floor wax; Dry cleaning kits; Fragranced oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners (non-cartridge systems), etc.

IFRA Category 10B Household aerosol/spray products: Animal sprays applied to animals; Air freshener sprays, manual, including aerosol and pump; Aerosol/spray insecticides

IFRA Category 11A Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate without UV exposure: Feminine hygiene conventional pads, liners, interlabial pads; Diapers (baby and adult); Adult incontinence pant, pad; Toilet paper (dry)

IFRA Category 11B Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate with potential UV exposure: Tights with moisturizers; Scented socks, gloves; Facial tissues (dry tissues); Napkins; Paper towels; Wheat bags; Facial masks (paper/protective) e.g., surgical masks not used as medical device; Fertilizers, solid (pellet or powder)

Products not intended for direct skin contact, minimal or insignificant transfer to skin: Candles of all types; Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods); Automated air fresheners and fragrancing of all types e.g. concentrated aerosol with metered doses, plug-ins, electrical, incense, liquid refills (cartridge); Air delivery systems; Cat litter; Cell phone cases; Deodorizers/maskers not intended for skin contact e.g. fabric drying machine deodorizers, carpet powders; Fuels; Insecticides e.g. mosquito coil, paper, electrical, for clothing, excluding aerosols/sprays; Joss sticks or incense sticks; Dishwash detergent and deodorizers for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch and sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes; Rim blocks (Toilet)
