### 4. FIRST AID MEASURES

#### Eye contact

Flush eyes with plenty of water for at least 20 minutes retracting eyelids often. Tilt the head to prevent chemical from transferring to the uncontaminated eye. Get immediate medical attention.

#### Skin contact

## 5. FIRE FIGHTING MEASURES

---

### Suitable extinguishing media

Use alcohol resistant foam, carbon dioxide, or dry chemical extinguishing agents. Water may be ineffective but water spray can be used to extinguish a fire if swept across the base of the flames. Water can absorb heat and keep exposed material from being damaged by fire.

### Unsuitable extinguishing media

Do not direct a stream of water into the hot burning liquid.

### Special protective equipment and precautions for fire-fighters

## 7. HANDLING AND STORAGE

---

### Precautions for safe handling

Mildly irritating material. Avoid unnecessary exposure. As with all chemicals, good industrial hygiene practices should be followed when handling this material. Avoid contact with material, avoid breathing dusts or fumes, use only in a well-ventilated area. Wash thoroughly after handling. Do not get in eyes, on skin and clothing. Use spark-proof tools and explosion-proof equipment. Ground and bond containers when transferring material. "Empty" containers retain product residue can be dangerous.

### Conditions for safe storage, including any incompatibilities

Store in a cool, dry place. Isolate from incompatible materials. Store in a cool place in original container and protect from sunlight. Keep away from heat, sparks, and flame. Do not store near combustible materials. Keep container closed when not in use. Keep away from sources of ignition. Store in a tightly closed container.
