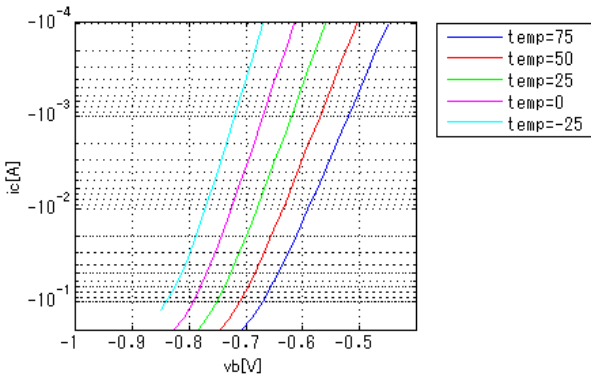

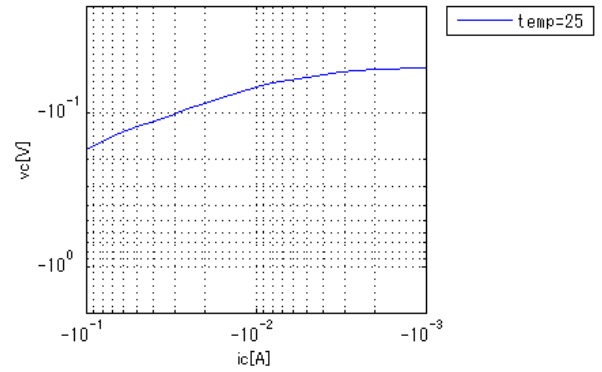

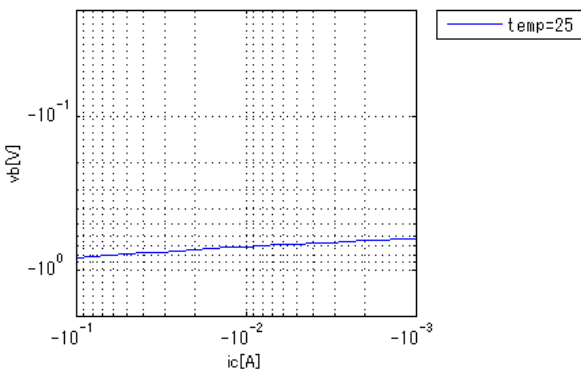

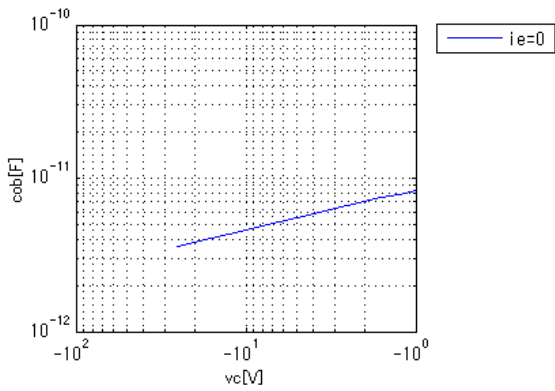


**fT Ic[Vce]**
