# **BEAUTY SPECIALISTS COURSE**

#### **OVERVIEW**

This Level 2 Beauty Qualification teaches you a variety of beauty skills including:

- Skincare & eye treatments
- Makeup
- Manicure & Pedicure
- Professional conduct and business awareness

There is the option to complete this with VTCT or ITEC.

There is no assignment work needed to complete the ITEC option, as it is end point assessed.

#### COST

The course is paid over 7 months at £300 per month. Costing £2100. A one off payment will reduce the cost by £100.

#### DURATION

All of our courses are flexible, however upon enrolment we like to set a realistic timescale & most students prefer to complete in 6 months. This is based on attending the centre 2 days per week.

Usual study days are Mondays & Saturdays.

#### ASSESSMENT

Each unit requires a successful completion of a practical observation, 70% pass in a theory exam & portfolio of practical evidence.

VTCT options also require 1-2 assignments per unit.

#### WHO IS THIS QUALIFICATION FOR?

The VTCT/ITEC Level 2 Beauty Specialist Techniques is a substantial vocational qualification that will prepare you for a career as a beauty therapist. This qualification is designed for anyone seeking the opportunity to start a career in the beauty industry and will support you to gain employment or start your own business as a beauty therapist as the units contained in this qualification cover all the skills and knowledge required for this role.

Throughout this qualification you will develop your knowledge and understanding of relevant anatomy and physiology, health and safety, client care and cosmetic beauty products and equipment. You will also develop a range of technical skills enabling you to provide a variety of treatments using different techniques. You will also develop interpersonal skills that will assist you to communicate effectively with clients.

#### **OVERVIEW**

- Waxing
- Makeup
- Manicure & Pedicure

There is the option to complete this with VTCT or ITEC. There is no assignment work needed to complete the ITEC option, as it is end point assessed.

#### COST

The course is paid over 10 months at  $\pm$ 300 per month. Costing  $\pm$ 3000. A one off payment will reduce the cost by  $\pm$ 100.

#### DURATION

All of our courses are flexible, however upon enrolment we like to set a realistic timescale & most students prefer to complete in 10-11 months. This is based on attending the centre 2 days per week.

Usual study days are Mondays & Saturdays.

#### ASSESSMENT

Each unit requires a successful completion of a practical observation, 70% pass in a theory exam & portfolio of practical evidence.

VTCT options also require 1-2 assignments per unit.

#### WHO IS THIS QUALIFICATION FOR?

The VTCT Level 2 NVQ Diploma in Beauty Therapy General is a substantial vocational qualification for learners seeking a career as an employed and/or self-employed beauty therapist. This qualification is based on the beauty therapy National Occupational Standards (NOS) and is recognised by the UK's leading professional bodies (The British Association of Beauty Therapy and Cosmetology (BABTAC) and the Federation of Holistic Therapists (FHT)) as being fit for purpose for preparing learners for a career as a beauty therapist.

Some differences you may see, is that there are less paperwork & assignments involved in ITEC qualifications, which makes some of their awards an appealing choice in beauty therapy.




