MIXING INSTRUCTIONS

Diamond Grow® Carbo[N] is compatible with liquid fertilizers, micro-nutrients, pesticides and water. The addition of Carbo[N] to these products should not be done without first testing compatibility on a small scale. When mixing with water, use a ratio of 1 gallon of Carbo[N] to every 9 gallons of water. This is applied prior to the addition of buffering agents and pesticides. DO NOT tank mix with carbonate based pesticides, this will result in significant decreases in efficacy. Follow all direction on pesticide labels prior to mixing with Carbo[N]. A jar test is always recommended prior to mixing on a large scale.
