ESAA – POND PREVENTION is an all-purpose pond water and surface cleaner that will show immediate results allowing treated waters, uninterrupted use. Within seconds of water activation, damage to algae in normally hard to treat areas such as stream beds, rocks, waterfalls, and all locations around the pond will quickly become evident. **ESAA** works quickly and dissipates just as fast with no lasting chemical residue of any kind. Not only clearing your water, **POND PREVENTION** will also help by adding oxygen to the water making a healthy environment for your fish and plants compared to other chemical algaecides.

ESAA is your personal water and surface cleaner saving you the usual time, money, mess, and effort required to catch your fish, drain the pond, wash and scrub the scum from the pond liner or stream, refill the pond and put the fish back hoping you don't stress or kill them. The usual 4-5-hour process can be eliminated forever by simply treating your pond weekly with a maintenance dose of **ESAA**. Use in combination with **ESAE-Natural Pond & Lake Conditioner** for your season long "clean pond" guarantee.

TYPICAL USAGE SITES:

- Water Gardens, Koi Ponds, Waterfalls, Fountains, Standing Water, and Water Collection Containers
- Also used on non painted surfaces such as: Floors, Walkways, Patios, Decks, Railings, Roofs, Shingles, Siding, Fiberglass, Boats, Piers, Docks, Stairs, Concrete, brick, Tile, Slate, Granite, Statues, Outdoor Furniture, Tennis Courts, Shorelines and Gravel

HOW ESAA WORKS IN WATER:

- Using the powerful granules, simply sprinkle or broadcast with a mechanical spreader or by hand, the product on the area you want to treat
- **ESAA** is water activated and effective cleaning is most easily achieved when algae are not yet well established
- Once the product is applied, it will fall through the water column (doesn't dilute) to make contact with the algae
- When applying **ESAA** to soil or gravel or other similar media, incorporate the product into the first inch of substrate for optimum effectiveness
- Immediate action will be observed with bubbling and bleaching/discoloration of algae

SPOT TREATMENT:

- Apply **POND PREVENTION** directly over infested area in dry form
- For waterfall applications, turn off pumps and allow **POND PREVENTION** to sit on the waterfall for a period 20 minutes and then turn pumps back on

LIQUID TREATMENT:

- 1. Make a solution of **POND PREVENTION** (refer to liquid application rates)
- 2. Spray this solution on the desired treatment surface until saturated
- 3. Let sit for 5 to 10 minutes
- 4. Rinse and re-apply if necessary

APPLICATION RATES:

- Light algae growth: 3 cups for every 1000 sq. ft. of surface area
- Heavy algae growth: 6 cups for every 1000 sq. ft. of surface area
