This appliance may be installed as an OEM installation in manufactured home (USA only) or mobile home and must be installed in accordance with the manufacturer's instructions and the *Manufactured Home Construction and Safety Standard, Title 24 CFR, Part 3280* in the United States, or the *Standard for Installation in Mobile Homes, CAN/CSA Z240 MH Series.* in Canada.

This appliance is only for use with the type(s) of gas indicated on the rating plate. This appliance is not convertible for use with other gases, unless a certified kit is used.

In the Commonwealth of Massachusetts installation must be performed by a licensed plumber or gas fitter.

Majestic gas inserts are designed for installations into solid fuel masonry or factory built fireplaces that have been installed in accordance with the National, Provincial, State and local building codes. Fireplaces are to be constructed of non-combustible materials and, in the absence of local or regional codes, meet criteria of NFPA 211. No additional outside air source is required.

**NOTICE:** This installation must conform with local codes. In the absence of local codes you must comply with the National Fuel Gas Code, ANSI Z223.1-latest edition in the U.S.A. and the CAN/CGA B149 Installation Codes in Canada.

#### NOT INTENDED FOR USE AS A PRIMARY HEAT SOURCE.

This appliance is tested and approved as either supplemental room heat or as a decorative appliance. It should not be factored as primary heat in residential heating calculations.

# D. High Altitude Installations

NOTICE: If the heating value of the gas has been reduced, these rules do not apply. Check with your local gas utility or authorities having jurisdiction.

When installing above 2000 feet elevation:

- In the USA: Reduce input rate 4% for each 1000 feet above 2000 feet.
- In CANADA: Input ratings are certified without a eduction of input rate for elevations up to 4500 feet (1370 m) above sea level. Please consult provincial and/or local authorities having jurisdiction for installations at elevations above 4500 feet (1370 m).

Check with your local gas utility to determine proper orifice size.

# E. Non-Combustible Materials Specification

Material which will not ignite and burn. Such materials are those consisting entirely of steel, iron, brick, tile, concrete, slate, glass or plasters, or any combination thereof.

Materials that are reported as passing ASTM E 136, Standard Test Method for Behavior of Materials in a Vertical Tube Furnace at 750 °C shall be considered non-combustible materials.

# F. Combustible Materials Specification

Materials made of or surfaced with wood, compressed paper, plant fibers, plastics, or other material that can ignite and burn, whether flame proofed or not, or plastered or unplastered shall be considered combustible materials.

#### G. Electrical Codes

**NOTICE:** This appliance must be electrically wired and grounded in accordance with local codes or, in the absence of local codes, with National Electric Code ANSI/NFPA 70-latest edition or the Canadian Electric Code CSA C22.1.

 A 110-120 VAC circuit for this product must be protected with ground-fault circuit-interrupter protection, in compliance with the applicable electrical codes. when it is installed in locations such as in bathrooms or near sinks.

# **2** Getting Started

# A. Design and Installation Considerations

Majestic gas inserts are designed for installations into solid fuel masonry or UL127 listed factory built fireplaces. No additional outside air source is required.

Installation MUST comply with local, regional, state and national codes and regulations. Consult insurance carrier, local building inspector, fire officials or authorities having jurisdiction over restrictions, installation inspection and permits.

Prior to installing the gas insert:

- Ensure chimney is constructed of non-combustible materials.
- Ensure chimney is clean and in good working order.
- Ensure that all chimney cleanouts fit properly to prevent air leakage into chimney.
- Ensure combustible mantel and surround clearances comply with insert requirements.
- Ensure all joints are properly engaged and the chimney is properly secured.
- Determine minimum fireplace size. See Section 3.A and 3.B.
- · Determine gas supply piping requirements.
- · Determine electrical wiring requirements.
- · Determine finishing details.
- Determine whether optional accessories—devices such as a wall switch or remote control—are desired.

Installation and service of this appliance should be performed by qualified personnel. Hearth & Home Technologies recommends HHT Factory Trained or NFI certified professionals.





Improper installation, adjustment, alteration, service or maintenance can cause injury or property damage. For assistance or additional information, consult a qualified service technician, service agency or your dealer.




Figure 2.1 Multi-Purpose Tool




Figure 2.2 Multi-Purpose Tool shipping Location




Figure 2.3 Multi-Purpose Tool Storage Options




Figure 2.4 Good Faith Wall Surface Temperatures Above Appliance

If installing a television (TV) above the appliance, see Section 3 of the appliance Owner's Manual.

- Installation and/or use of any component part not approved by Hearth & Home Technologies.









# **B. Minimum Fireplace Opening**

Minimum fireplace opening requirements for a standard 3/4 inch deep surround are shown in Figure 3.7. For smaller openings, a custom surround is available.

WARNING! Risk of Fire or Burns! Provide adequate clearance around air openings and for service access. Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.

### For Installation into a Zero Clearance Wood burning fireplace:

- The brick (refractory), glass doors, screen rails, screen mesh and log grates can be removed from a factory built firebox in order to gain minimum gas insert opening requirements.
- Any smoke shelves, shields and baffles may be removed from the factory built firebox if attached with mechanical fasteners.




Figure 3.5 Solid Fuel Floor Clearance

• The appliance may not be placed directly on the base of the outer wrap, a 1/4 inch airspace <u>MUST</u> be provided between the insert and the floor of the outer wrap. Use the leveling legs to raise the insert a minimum of 1/4 inch. The original fireplace may never be returned to solid fuel in this condition. The sidewalls and top structure of the firebox may not be altered with the exception of removable baffles and dampers.

- The metal floor of the solid fuel firebox may be removed to facilitate the installation of the insert.
- Cutting of any sheet metal parts of the fireplace in which the gas fireplace insert is to be installed is prohibited, except the floor as tested for and as noted above.
- A minimum 1/4 inch gap from the bottom of the appliance to the metal floor of the solid fuel firebox is <u>REQUIRED</u>. See side view in Figure 3.5.
- Manufactured gas inserts can be installed as a zero clearance appliance. See Section 3C for clearance detail.





Figure 3.6 Minimum Required 1/2 in. Gap

#### **Custom Surrounds**

Custom surrounds are available. See your dealer for information. Standard surrounds are 3/4 inches deep. Custom surrounds are available up to 3 inches deep. A 3 inch deep surround would reduce the unit opening depth (E\*) by 2-1/4 inches (3 in. - 3/4 in. = 2-1/4 in).

#### On Site Custom Surrounds

On site custom surrounds are available. See your dealer for information. On site custom surrounds are flush and have no depth. A flush surround would increase the unit opening depth (E\*) by 3/4 inch.

<sup>\*</sup>Unit depth is measured to the back of the surround to give the depth needed for installation.

#### C. Wall Extension

#### Surrounds MUST overlap wall extension.

A non-combustible wall extension can be used to cover an existing masonry surface. Wall extensions are typically used to improve cosmetics.

**WARNING!** Risk of Fire! Comply with all minimum clearances to combustibles as specified. Framing or finishing material closer than the minimums listed must be constructed entirely of noncombustible materials (i.e., steel studs, concrete board, etc).

Combustible facings must not extend behind the insert surround. See Section 1.E and 1.F.

#### **Non-Combustible Materials Specification**

Material which will not ignite and burn. Such materials are those consisting entirely of steel, iron, brick, tile, concrete, slate, glass or plasters, or any combination thereof.

Materials that are reported as passing ASTM E 136, Standard Test Method for Behavior of Materials in a Vertical Tube Furnace at 750 °C.




Figure 3.8 Non-Combustible Framing Requirement




Figure 3.9 Non-Combustible Facing Requirement




Figure 3.10 Non-Combustible Framing / Facing Requirement

- Facing and/or finishing materials must not interfere with air flow through decorative fronts.
- Facing and/or finishing materials must never overhang into the glass opening.
- Observe all clearances when applying combustible materials.
- Maximum depth of wall extension is 12 inches. This may be limited by the flex pipe's ability to connect to the starting collar.
- Covering combustible materials with non-combustible materials does not qualify material as non-combustible.

WARNING! Risk of Fire! DO NOT apply combustible materials beyond the minimum clearances. Comply with all minimum clearances to combustibles as specified in this manual. Overlapping materials could ignite and will interfere with proper operation of decorative fronts.




Figure 3.11 Transition Sealing Detail for Wall Extensions (Side View)

#### **Wall Extension**

Wall extension must be sealed to existing masonry wall. See Figure 3.11. Framing studs may not sit flush against existing masonry wall. In order to keep heat from escaping behind the wall this transition must be sealed.

Seal with a high temperature silicone 300 °F.

and / or

 Packing insulation into voids between the masonry wall and steel studs is acceptable.

**Note:** Combustible materials may be used to seal wall extension to existing masonry wall as long as it is outside the non-combustible zone.

#### **Painting**

If desired finishing includes a painted wall, a high-quality 100% acrylic latex paint with a high-quality latex primer base coat are recommended around the appliance to limit discoloration. Oil-based or standard acrylic paints may be more prone to discoloration due to heat exposure.

#### **Drywall Joint-Crack Prevention and Repair**

Drywall joints around the fireplace will be affected by exposure to elevated temperatures, along with other environmental, structural factors due to new construction, and methods used to install and finish the drywall. If a crack does emerge adjacent to the fireplace, it can be permanently repaired by filling it with a paintable latex caulk, followed by repainting.

Some movement of the screws used to secure the noncombustible board to the appliance/surround framing is expected. If a blemish begins to show over a screw head, sand the surface to remove the blemish and repaint.

NOTE: Concealed sections of 3 in. flex pipe must be contained inside existing masonary fireplace flue vent or installed into an existing wood burning vent system.

# D. Mantel, Wall Projections, & Hearth **Extensions**

WARNING! Risk of Fire! Comply with all minimum clearances to combustibles as specified. Framing or finishing material closer than the minimums listed must be constructed entirely of noncombustible materials (i.e., steel studs, concrete board, etc).

Clearance to combustible material under the insert is 1/4 inch (6 mm).

 Use leveling legs to raise insert minimum 1/4 inch (6 mm) above combustible material or outer wrap of factory

Combustible facings must not extend behind the insert surround. For non-combustible material specifications refer to Section 1.E and 1.F.





Figure 3.12 Clearances to Mantel Legs or Wall Projections (Acceptable on both sides of surround opening)




Figure 3.14 Minimum Vertical and Maximum Horizontal Dimensions - Combustible




Figure 3.16 Minimum Required 1/2 in. Gap to Bottom of Front




Figure 3.17 Flooring & Hearth Material




Figure 3.18 Hearth - Combustible Material Exception




Figure 3.19 Solid Fuel Floor Clearance



# **Installation Preparation**

Prepare the existing solid fuel masonry or factory built non-combustible firebox for installation.

#### A. Cleaning

Prior to installing the gas insert:

• Ensure that the woodburning fireplace cavity is clean and free of ash, soot, and other debris.

# B. Flue Damper

Fully lock the solid fuel fireplace's flue damper in the open position, OR completely remove it.

# C. Gas Line

**Note:** If the factory built fireplace has no gas access hole provided, an access hole of 1 inch (25 mm) diameter or less may be drilled through the lower sides or bottom of the firebox in a proper workmanship - like manner. This access hole must be plugged with non-combustible insulation after the gas supply line has been installed.

- Install gas line to the factory provided flex line. See Figure 4.1.
- Check local codes and gas line sizing requirements following NFPA54. See Section 7.
- It is recommended that extra length of gas line be installed within the existing wood burner or masonry fireplace to allow removal of the insert for future servicing needs.

# D. Fireplace Conversion Notice

The fireplace conversion notice is included in the appliance manual bag. Permanently attach the label with the following warning to the inside lower back of the fireplace firebox into which the insert is being installed. Silicone or mechanical fasteners may be required to properly secure the label.

**WARNING!** Risk of Fire! This fireplace has been converted for use with a gas fireplace insert only and cannot be used for burning wood or solid fuels unless all original parts have been replaced, and the fireplace re-approved by the authority having jurisdiction.

#### E. Electrical Outlet Box

An outlet box may be installed in a bottom back corner of the existing solid fuel masonry or factory built fireplace to power the appliance. Each unit ships standard with a cord assembly to permit blowers or other optional accessories to be used. The accessories plug into the new outlet box or may be routed out onto the hearth to a nearby outlet.

NOTICE: DO NOT wire 110-120 VAC to wall switch.




Figure 4.2 Electrical Outlet Detail








Figure 5.2 Min. / Max. Venting Requirement




Figure 5.3 Firebox Baffle

## C. Venting Components






Figure 5.5 Optional SLP Venting Configuration - Vertical Termination

# E. Connecting Vent Pipe

Reference instructions in the termination kit.

- Install the 3 in. flexible vent pipe(s) down through the chimney.
- Secure the exhaust flexible vent pipe to the exhaust starting collar on top of the appliance with three screws.
   See Figure 5.1.
  - For best results in cold climate be sure 3 in. flex is flush and tight to the collar slide plate assembly. Seal with stove cement or aluminum foil tape. Do not use silicone.
- Use 3 screws to attach the section of inlet air vent to the inlet air starting collar on the collar slide plate assembly.
   See Figure 5.1. NOTE: The collar slide plate assembly may be removed from appliance to aid installation and service.



- Trim chimney top plate to minimize excess overhang or bend over flue tile. See Figure 5.6.

# F. Placing, Securing and Leveling the Appliance

**WARNING!** Risk of Explosion/Combustion Fumes! Connect vent sections per installation instructions.

- Connect exhaust vent pipe ONLY to exhaust starting collar and termination cap center collar.
- Connect inlet air vent ONLY to inlet air collar on appliance and either the termination cap inlet air collar OR terminate within chimney.
- DO NOT allow vent to sag below connection point to appliance.
- Install insert (without surround attached) into existing fireplace while pulling collar slide plate assembly forward.




Figure 5.7 Leveling Leg Detail

- Install gas line into hole provided on side. See Figure 5.7.
- Secure collar slide plate assemby to appliance by securing with #8 screw. See Figure 5.1.
- Level the appliance from side to side and front to back.
   Adjust leveling legs to desired vertical position so appliance is level. Use the leveling bolts included with the manual bag.
- Position any excess flexible vent pipe back up into chimney without sagging. Twist and push flex vent together to shorten.
- Attach surround. Follow instructions for surround installation included with the front.
- Push insert into the opening so that it tightly overlaps the fireplace opening.

**WARNING!** Risk of Fire! Only an approved Hearth & Home Technologies surround may be used to cover integral grills on solid fuel burning fireplaces. No other components such as shrouds, sheetmetal plates, etc., may be used to seal off vents.




Figure 5.8 Minimum Height from Roof to Lowest Discharge Opening



# **Electrical Information**

#### A. General Information

**WARNING!** Risk of Shock or Explosion! DO NOT wire 110-120 VAC to the valve or to the appliance wall switch. Incorrect wiring will damage controls.

**NOTICE:** This appliance must be electrically wired and grounded in accordance with local codes or, in the absence of local codes, with **National Electric Code ANSI/NFPA 70-latest edition** or the **Canadian Electric Code CSA C22.1.** 

- This appliance comes with a 110-120 VAC cord assembly. This is required for proper operation of the appliance (IntelliFire™ Touch Ignition). An outlet box may be installed in a bottom back corner of the existing solid fuel masonry or factory built fireplace to plug in the cord assembly, or the supplied power cord may be routed out onto the hearth to a nearby outlet.
- A 110-120 VAC circuit for this product must be protected with ground-fault circuit-interrupter protection, in compliance with the applicable electrical codes, when it is installed in locations such as in bathrooms or near sinks.
- Low voltage and 110-120 VAC voltage cannot be shared within the same wall box.
- In some instances, the spark ignition of the fireplace may cause intermittent, non-damaging, interference during the lighting sequence with a TV plugged into the same circuit. It is recommended that the fireplace and TV use different circuits to mitigate the interference potential. If interference is occurring on the same circuit, the use of surge protectors may help alleviate the interference.

NOTICE: DO NOT wire 110-120 VAC to wall switch.




Figure 6.1 Electrical Outlet Detail

# **Battery Pack**

Battery pack is not factory installed in appliances. See appliance manual bag for battery pack. Battery pack should only be installed during power outages.

**NOTICE:** Batteries should only be used as a power source in the event of an emergency power outage. Batteries should not be used as a primary long-term power source. Battery polarity must be correct when installing batteries.

DO not store batteries in the battery pack when the appliance is powered by the 6 volt transformer connected to permanent electrical service. Store battery pack in apppliance manual bag when not in use.




Figure 6.2 IntelliFire™ Touch Wiring Diagram




Figure 6.3 Cover Plate Removed (Option 1)




Figure 6.4 Through Valve Plate Opening (Option 2)




Figure 6.5 Cover Plate Removal (Option 1)




Figure 6.6 Through Valve Plate Opening (Option 2)

# **7** Gas Information

#### A. Fuel Conversion

- Make sure the appliance is compatible with available gas types.
- Conversions must be made by a qualified service technician using Hearth & Home Technologies specified and approved parts.
- Reference the following diagrams for gas shut off detail and component access.
- Reference Section 9.A to remove fixed glass assembly.




Figure 7.1 Gas Shut-off

- Use multi-purpose tool to assist with gas shutoff. See Figure 7.1. The gas ball valve is in the "OFF" position from manufacturer.
- Glass clip assemblies can be removed for additional component accessibility.




Figure 7.2 Glass Clip Assembly Removal




Figure 7.3 Component Tray

#### B. Gas Pressure

- Install regulator upstream of valve if line pressure is greater than 1/2 psig.

#### C. Gas Connection

- Refer to Reference Section 3 for location of gas line access in appliance.
- The gap between supply piping and gas access hole may be caulked with caulk with a minimum of 300 °F continuous exposure rating or stuffed with noncombustible, unfaced insulation to prevent cold air infiltration.
- Ensure that gas line does not come in contact with outer wrap of the appliance. Follow local codes.
- Pipe incoming gas line to the factory supplied flex line.
   See Figure 7.4.
- Connect incoming gas line to the 1/2 in. (13 mm) connection on manual shutoff valve.

**WARNING!** Risk of Fire or Explosion! Support control when attaching pipe to prevent bending gas line.

A small amount of air will be in the gas supply lines.

**WARNING!** Risk of Fire or Explosion! Gas build-up during line purge could ignite.

- Purge should be performed by qualified service technician.
- Ensure adequate ventilation.
- Ensure there are no ignition sources such as sparks or open flames.

Light the appliance. It will take a short time for air to purge from lines. When purging is complete the appliance will light and operate normally.

WARNING! Risk of Fire, Explosion or Asphyxiation! Check all fittings and connections with a non-corrosive commercially available leak-check solution. DO NOT use open flame. Fittings and connections could have loosened during shipping and handling.

# D. High Altitude Installations

**NOTICE:** If the heating value of the gas has been reduced, these rules do not apply. Check with your local gas utility or authorities having jurisdiction.

When installing above 2000 feet elevation:

- In the USA: Reduce input rate 4% for each 1000 feet above 2000 feet.
- In CANADA: Input ratings are certified without a reduction of input rate for elevations up to 4500 feet (1370 m) above sea level. Please consult provincial and/or local authorities having jurisdiction for installations at elevations above 4500 feet (1370 m)

Check with your local gas utility to determine proper orifice size.

# E. Air Shutter Setting




Figure 7.5 Air Shutter

Air shutter settings should be adjusted by a qualified service technician at the time of installation. The air shutter is set at the factory for minimum vertical vent run. Adjusting air shutter may be desired for longer vent runs. See Figure 7.5.

**NOTICE:** If sooting occurs, provide more air by opening the air shutter.




Figure 7.6 Gas Valve Detail




Figure 8.1 Clearances to Mantel Legs or Wall Projections (Acceptable on both sides of surround opening)




Figure 8.2 Minimum Vertical and Maximum Horizontal




Figure 8.3 Minimum Vertical and Maximum Horizontal Dimensions - Combustible




Figure 8.4 Minimum Required 1/2 in. Gap




Figure 8.5 Flooring & Hearth Material

- All flooring and hearth material must remian below the bottom of the surround. See Figure 8.5.




Figure 8.6 Hearth - Combustible Material Exception

- Combustible flooring may be located in front of the appliance. Exception - no vinyl / adhesive flooring. See Figure 8.6.
- 1/2 inch gap under the bottom of the front must be maintained. See Figure 8.4.




Figure 8.7 Solid Fuel Floor Clearance

- A minimum 1/4 inch gap from the bottom of the appliance to the metal floor of the solid fuel firebox is <u>REQUIRED</u>. See side view in Figure 8.7.
- Combustible flooring underneath the appliance is acceptable with a 1/4 inch gap. See Figure 8.7.

# 9 Appliance Setup

## A. Fixed Glass Assembly

**WARNING!** Risk of Asphyxiation! Handle fixed glass assembly with care. Inspect the gasket to ensure it is undamaged and inspect the glass for cracks, chips or scratches.

- DO NOT strike, slam or scratch glass.
- DO NOT operate fireplace with glass removed, cracked, broken or scratched.
- Replace as a complete assembly.

### Removing Fixed Glass Assembly

**CAUTION! Handle fixed glass assembly with care.** Glass is breakable.

- · Avoid striking, scratching or slamming glass
- · Avoid abrasive cleaners
- DO NOT clean glass while it is hot
- The glass assembly fastens to the fireplace in four places. Four of the fastening mechanisms are springloaded glass latches. An example of the glass latch is shown in Figure 9.2.
- To release glass assembly, use the supplied multipurpose tool to pull the two bottom spring-loaded latches forward and allow them to retract away from the glass assembly. Tilt the bottom of the glass assembly outward until the top latches disengage.




Figure 9.1 Multi-PurposeTool

## **Replacing Fixed Glass Assembly**

- Tilt the top of the glass assembly toward fireplace and slide glass assembly upward to engage top latches. Verify top latches are fully engaged and then fasten the two bottom latches using the supplied multi-purpose tool.
- Reinstall door or decorative front.




Figure 9.2 Glass Seal Plate

**WARNING!** Glass seal plate must be properly installed. Risk of elevated component temps and carbon monoxide exposure.

## B. Remove the Shipping Materials

Remove shipping materials from inside or underneath the firebox.

**Note:** Remove the zip ties from the appliance that hold the electrical cord, gas flexline and multi-purpose tool in place for shipping.

## C. Clean the Appliance

Clean/vacuum any sawdust that may have accumulated inside the firebox or underneath in the control cavity.

#### D. Accessories

Install approved accessories per instructions included with accessories. Contact your dealer for a list of approved accessories.

WARNING! Risk of Fire and Electric Shock! Use ONLY Hearth & Home Technologies-approved optional accessories with this appliance. Using non-listed accessories could result in a safety hazard and will void the warranty.

## E. Mystic Embers Placement

**WARNING!** Risk of Explosion! Follow mystic ember placement instructions. **DO NOT** place mystic embers on burner. Improperly placed mystic embers interferes with proper burner operation.

Mystic embers is shipped with this gas appliance. To place the embers:

- Embers CANNOT be placed on the burner.
- · Place embers in front of and to the sides of the burner.




Figure 9.3 Placement of Embers

- Use mystic embers to mask transition between base refractory and base pan. See Figure 9.3.

#### F. Ember Placement

**WARNING!** Risk of Explosion! Follow ember placement instructions in manual. Replace ember material annually. Improperly placed embers interfere with proper burner operation.

Ember material is shipped with this gas appliance. To place the ember material:

- Embers CANNOT be placed directly over burner ports that are indicated in Figure 9.3 or in pilot area as indicated in Figure 9.3.
- Embers may be placed on the ports in areas indicated in Figure 9.3. These embers must be placed loosely over the port holes, not pressed down on or into the holes. Create a single layer, no more than 1/4 inch thick.
- Failure to follow this procedure will likely cause lighting and sooting problems.
- Save the remaining ember materials for use during appliance servicing. The embers provided should be enough for 3 to 5 applications.




Figure 2. Empty Firebox with Hearth Front Installed

**LOG #1:** With the pilot hood cutout of Log #1 on the left, place the cutout over the pilot hood and set Log #1 on the basepan. Slide the log back until it contacts the air scoop. See Figure 3.




Figure 4. Log #2 Installed

**LOG #2:** With the flat spot of Log #2 to the left, place it on the burner and slide it to the right until it contacts log pin C. Then slide the log forward until it contacts log pins A and B. See Figure 4.




Figure 5. Log #3 Installed

**LOG #3:** With the burnout area facing right, place the back end of log #3 on the left flat spot of Log #1. The front end will sit on the base pan and line up with edge of the base refractory. The front end of the log will sit about 1/4" from the left wall of the firebox. See Figure 5.

**LOG #4:** The burnout area of the log will face left. Place the big end of log #4 centered against log pin D and the small end on the flat spot of Log #1. See Figure 6.

**LOG #5:** With the bark side of log #5 facing right, place the small end of Log #5 on the flat spot of Log #4. The big end of log #5 will line up with the front edge of the refractory embers and sit just to the left of the grout line. See Figure 7.




Figure 8. Log #6

**LOG #6:** With bark side of log facing right, place Log #6 onto Log #2. The point of the big end of Log #6 will line up with the front edge of the base refractory embers. The bark corner of log #6 will sit about 1.5" from Log #5. See Figures 8 & 9.

**LOG #7:** With bark side facing left, place the small end of Log #7 on the flat spot of Log #2. Place the large end of Log #7 on the flat spot of Log #1. See Figure 10.

**Mystic Embers:** The RUBY come standard with Mystic Embers. Refer to the appliance installation manual for instructions on how to properly install the Mystic Embers in the appliance. The Mystic Embers must be installed after the logs are installed.

**LOG #1:** With the pilot hood cutout on the left, place the right end of Log #1 against log pin F and then lower it down over the pilot hood. Slide the log back until it contacts the air scoop. See Figure 3.




Figure 2. Burner Location


Figure 4. Log #2 Installed

**LOG #2:** With the burnout area facing right, place the center of the small end of Log #2 against log pin A. Place the big end of the log on the flat spot of Log #1. See Figure 4.

**LOG #3:** The burnout area of Log #3 will face forward. Place the right end of Log #3 centered against log pin E and the left end on the flat spot of Log #1. See Figure 5.

**LOG #4:** With the flat spot of Log #4 to left, place it on the burner and slide it to the right until it contacts log pin D. Then slide the log forward until it contacts log pins B and C. See Figure 6.

**LOG #5:** The big end of Log #5 will sit on the flat spot of Log #2 and the small end will sit on the ember area of the base refractory as shown in Figure 7.

**LOG #6:** With split side of Log #6 to the left, place small end of the log on the flat spot of Log #3. The big end of the log will line up with the front edge of the refractory embers and the grout line as shown in Figure 8.

**LOG #7:** Place small end of Log #7 onto the flat notch of Log #4. Place big end of Log #7 on the flat spot of Log #1. The big end of Log #7 will touch the end of Log #3. See Figure 9.

**LOG #8:** With bark side of log #8 facing left, place it onto Log #4. The big end of Log #8 will line up with the front edge of the base refractory embers. The corner of Log #8 will sit about 1.25" from the corner of Log #6. See Figures 10 & 11.




Figure 2. Burner Location

**LOG #4:** With the flat spot of Log #4 to the left, place it on the burner and slide it to the right until it contacts log pin D. Then slide Log #4 forward until it contacts log pins B and C. See Figure 6.

LOG #5: Place the small end of Log #5 in the flat notch of Log #4 and the big end in the flat spot of Log #1. See Figure 7.

**LOG #6:** With split side of Log #6 facing left, slide it under Log #3 until it contacts Log #1. Slide Log #6 to the right until it contacts log pins E and G. See Figure 8.

**LOG #7:** With the bark side of Log #7 facing forward place the big end of the log on the flat spot of Log #2. The small end of Log #7 will rest on the base pan, lined up with the edge of the base refractory and the air slot in the base pan. See Figure 9.

**LOG #8:** With the bark side of Log #8 facing left, place the flat end of the log on the flat spot of Log #3. The flat end of Log #8 should be flush with the back side of Log #3. The pointed end of Log #8 will line up with the edge of the refractory embers and sit just to the left of the grout line. See Figure 10.

**LOG #9:** With the bark side of Log #9 facing right, set the log onto the flat spot of Log #4. The tip of the pointed end of the log will contact Log #2 just to the right edge of the burnout area of Log #2. The big end of the log will sit on the refractory embers. See Figure 11.

## H. Install Decorative Front and Surround

A decorative front and surround is required to complete this installation. Installation instructions are included with the decorative front and surround. Consult your dealer for a list of decorative front and surround options.

**WARNING!** Risk of Fire! Install ONLY doors or fronts approved by Hearth & Home Technologies. Unapproved doors or fronts may cause fireplace to overheat.

This fireplace has been supplied with an integral barrier to prevent direct contact with the fixed glass panel. DO NOT operate the fireplace with the barrier removed.

Contact your dealer or Hearth & Home Technologies if the barrier is not present or help is needed to properly install one.

For more information refer to the instructions supplied with your decorative front.




Figure 9.4 Surround Reset Switch

See Figure 9.4 for Reset Switch Detail. The Reset Switch included with the surround needs to be wired to the appliance. Reference front/surround instructions (included with the decorative front) and wiring diagram in Figure 6.2.

 Reset switch must be installed and in the "ON" position for appliance to operate.

**NOTE:** For on site custom surround details, see instructions included with the surround.




Figure 9.5 Required 1/2 in. Gap

## I. Appliance Break-In

Follow the initial break-in procedure below to cure the materials used to manufacture the fireplace and the finishing materials around it.

- The fireplace should be run three to four hours continuously on high flame and high fan.
- Turn the fireplace off and allow it to cool completely.
- Remove fixed glass assembly. See Section 9.A.
- · Clean fixed glass assembly.
- Replace the fixed glass assembly and run continuously on high an additional 12 hours.

**NOTICE!** This product comes equipped with a fan that provides remote control of heat output. See Section J. Set the fan speed to high on the RC400 remote control during the first three to four hours of break-in operation. This break-in will ensure optimum speed control of the fans during subsequent use.

**Note:** The IntelliFire  $^{TM}$  Touch system has a safety feature that automatically shuts down the fireplace after 9 hours of continuous operation without receiving a command from the remote control. If this occurs, restart the appliance.

## NOTICE! Open windows for air circulation during fireplace break-in.

- Some people may be sensitive to smoke and odors.
- · Smoke detectors may activate.

## J. Heat Management

#### **Heat Output**

Heat Output is managed through the RC400 remote control that comes standard with the fireplace.

- · Turn the appliance on and off.
- Adjust the height of the flame by varying the input using the remote control.
- · Adjust the fan speed.

For more information, see the instructions that accompany the remote control.

**NOTICE!** Set the fan speed to high on the RC400 remote control during the first three to four hours of break-in operation. This break-in will ensure optimum speed control of the fans during subsequent use.




Figure 10.1 Direct Vent Flex Liner Kits




Figure 10.2 Direct Vent Flex Liner Accessory Kits
