REVIEW THE CRITERIA BELOW FOR SPONSORSHIP CONSIDERATION:

1. Pairing Speed Demon with competitor lighting products will not be tolerated.
2. Full sponsorship (no charge for the product, shipping charges apply).
3. Partial sponsorship (shipping and discounted pricing apply).
4. Social Media posts featuring your project build must clearly tag our brand and use the following tags: @speeddemonlights #speeddemonlights #conquerdarkness.
 - Must post at least once a week.
5. Photographs, once the product is installed, are required within 2 weeks.
 - Required: Angle Shot, Product Close-Ups, Full Vehicle Front, Full Vehicle Side, Full Vehicle Rear.
 - Lifestyle photos (You using your vehicle in your everyday life/hobby).
6. Speed Demon Lights vinyl logos are to be prominently displayed on both sides of the vehicle at all times and may not be smaller than 8 inches.
7. If the vehicle is wrapped, a Speed Demon logo must be prominent.
8. Copy of front and back of credit card and a copy of your driver's license.
