**1. GENERAL**

**Color:** Orange Sunset

**Purpose:** The ink is intended for permanent makeup treatments on lips.

**2. HAZARDS IDENTIFICATION**

The product is considered non-hazardous to humans and the environment. May cause an allergic reaction in people sensitive to the product.

**Eyes:** the presence of alcohol can cause moderate irritation, lacrimation, and redness;

**Skin:** may cause irritation or allergic dermatitis in people prone to allergic reactions;

**Ingestion:** causes no side effects;

**Inhalation:** in case of proper and normal use, inhalation of the product is unlikely;

The product contains no substances classified as hazardous to the environment. When used properly, the product is not dangerous.

The ink has a **hybrid** composition. The composition contains both **organic** and **inorganic** pigments.

**The purpose of components:**

**Distilled Water** — is transport medium used for implantation of pigment particles into the skin;

**Glycerin** — solvent and moisturizer. It moisturizes the injured area of the skin. It has hygroscopic properties;

**Isopropyl Alcohol** — solvent and defoaming agent. It has antiseptic properties;  
**Benzyl Alcohol** — the simplest aromatic alcohol, solvent. It has antiseptic properties.

#### 4. FIRST AID MEASURES

**In case of eye contact:** flush eyes for 15 minutes, keep eyes open. Consult a doctor;  
**After implantation into the skin:** 3 hours after the treatment, wash with warm water and soap. Do not use antibacterial and healing agents. If necessary, apply Vaseline-based cosmetic cream;

**If swallowed:** drink plenty of water (1 liter or more), do not induce vomiting. Consult a doctor;

**Inhalation** of the product is unlikely. If an allergic reaction occurs, consult a doctor;

#### 5. INK STORAGE

Vials must be tightly sealed;  
Shelf life after opening: 12 months;  
Store in a cool, dry place;  
Avoid exposure to sunlight;  
Do not store near heating appliances;  
Do not freeze.

#### 6. PERSONAL PROTECTIVE EQUIPMENT WHEN WORKING WITH PIGMENTS

**Respiratory protection:** no special respiratory protection required. It is recommended that permanent makeup treatment sessions be performed in a well-ventilated room while wearing a disposable medical mask;

**Hand protection:** nitrile gloves are recommended;

**Eye protection:** no special eye protection is required. If necessary, protective goggles can be used to protect the eyes from splashing;

**Appearance:** liquid, free of foreign matter;

**Color:** corresponds to the color of products of a particular denomination;

**Smell:** a faint odor of ammonia;

**pH:** 2.0 to 6.0;
