



CONSIGNMENT AGREEMENT

This Consignment Agreement (this "Agreement") is made effective as of _____ by and between Jasper Designs LLC and ("Consignor"- Please Print Name)_____

The parties agree as follows:

- I RIGHT TO SELL. In accordance with this Agreement, consignor grants Jasper Designs LLC an exclusive right to sell the items under the terms of this Agreement Consignor agrees to deliver to Jasper Designs LLC, on consignment, the item(s) listed on the attached schedule. Jasper Designs LLC agrees to devote its best efforts to the sale of the item(s). All sales prices and terms of sale shall be determined by mutual consent of the parties. Standard consignment is a 50/50 split. There may be additional charges for pick-up of consignment items.
II. PROCEEDS OF SALES. Jasper Designs LLC will pay to consignor their portion of sales. Payments will be made to the Consignor by check or Venmo within 30 days of sale.
II Jasper Designs LLC reserves the right to reduce the price of the item(s) according to the following schedule: Up to 20% immediate discount, an additional 20% reduction after 30 days. After 60 days, the consignor will be contacted and asked to pick up item(s). If item(s) are not picked up within two weeks, Jasper Designs LLC will donate the item(s) to a charity of their choice.
IV RECORDS. Jasper Designs LLC shall keep accurate records regarding the quantities of the items that are sold. Consignor shall have the right to inspect such records from time to time after providing reasonable notice of such intent to Jasper Designs LLC.
V TITLE TO MERCHANDISE. Consigned merchandise shall remain the property of Consignor until sold.
VI LOSS AND INSURANCE. Jasper Designs LLC shall not be responsible for any shortages, loss, theft or damage..
VII WARRANTIES. Neither party makes any warranties with respect to the use, sale or other transfer of the items by the other party or by any third party.
VIII TERMINATION. This Agreement may be terminated by either party by providing written notice to the other party, via text, email or handwritten.
IX ENTIRE AGREEMENT. This Agreement contains the entire agreement of the parties with respect to the subject matter of this Agreement and there are no other promises or conditions in any other agreement, whether oral or written. This Agreement supersedes any prior written or oral agreements between Jasper Designs LLC and Consignor with respect to the subject matter of this agreement.
X AMENDMENT. This Agreement may be modified or amended, if the amendment is made in writing and is signed by both Jasper Designs LLC and Consignor.
XI APPLICABLE LAW. This Agreement shall be governed by the laws of the State of Florida.
XII SIGNATORIES. This Agreement shall be signed by and on behalf of Jasper Designs LLC by designees listed below. This Agreement is effective as of the date first written above.
