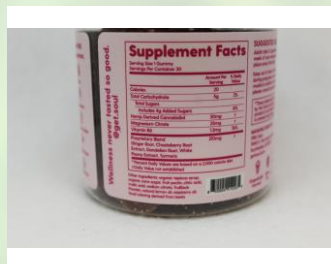

D8-THC and exo-THC). ND=None detected above the limits of detection (LOD), which is one third of Limit of Quantification (LOQ). For values reported as “<LOQ”, the estimated value is included in the calculated Total.

This sample was analyzed by elemental analysis using Inductively Coupled Plasma Mass Spectrometry (ICP-MS) for the identification of heavy metal constituents.
